Recommendation of Approval (Revised) SR 180 Officially Designated State Scenic Highway August 26, 2015

BACKGROUND: On February 23, 2015, District Landscape Architecture received Resolution #15-030 (attached) from the County of Fresno, Department of Public Works and Planning. This Resolution states, in part, that the County has adopted a Visual Assessment (VA) and Corridor Protection Program (CPP) for State Scenic Highway Designation for eastern segments of SR 180 in Fresno County from Trimmer Springs Road to the Tulare County line and the Kings Canyon National Park boundary north of General Grant Grove to the Kings Canyon National Park boundary near Cedar Grove. Note: These boundaries correspond to the post miles (PM) 74.9 to 110.8 and PM 112.1 to 137.9 in Fresno County.

Resolution #15-030 is the result of several years of dedicated effort and teamwork by the County of Fresno Department of Public Works and Planning, a local community group (Sierra Gateway Trust), and District Landscape Architecture. This collaborative effort consisted of numerous meetings, both internal and public, as well as public hearings including the Fresno Council of Governments (FCOG) and the Fresno County Board of Supervisors.

Final approval by the Caltrans Director will establish the first Officially Designated Scenic Highway in Caltrans District 6.

PROJECT DESCRIPTION/PROPOSAL: On March 23, 2015, the County of Fresno submitted a request seeking Official State Scenic Highway Designation for 60.7 miles of SR 180 in Fresno County from Trimmer Springs Road (PM 74.9) to the Tulare County line (PM 110.8), and from the Kings Canyon National Park boundary north of General Grant Grove (PM 112.1) to the Kings Canyon National Park boundary near Cedar Grove (PM 137.9).

Note: SR 180 is not a State Route through either of the two sections of Kings Canyon National Park; it is a National Park Highway. The first segment of SR 180 ends at the entrance to the Grant Grove section (west section, PM 110.8 in Tulare County), and the second segment begins at the north boundary of the Park, which is the end of that section of the Park at PM 112.1 (the Park/Fresno County boundary), and continues to PM 137.9 which is the entrance to the Cedar Grove section of the Park, (the Fresno County/Park boundary), and the end of SR 180 in Fresno County.

REVIEWS AND RECOMMENDATIONS: The District Scenic Highway Coordinator (DSHC) is recommending approval of the request from the County of Fresno for Official Scenic Highway Designation, with revised post miles as shown below, and in the attached October 13, 2015 letter to the Sierra Gateway Trust, as follows:

The request from Fresno County to begin the Scenic Highway at PM 74.9 (Trimmer Springs Road), is being revised to start at PM 78.6 (Alta Main Canal), due to the planned construction project to realign SR 180 from PM 74.1 to PM 78.6. When the construction project is complete, that part of the existing route will be relinquished to the County of Fresno and would no longer be part of the State Highway system. Therefore, it would be more appropriate at this time to remove that portion from the proposed designation and evaluate the newly re-aligned portion of SR 180 for inclusion in the State Scenic Highway designation after construction is complete.

The County of Fresno has fulfilled all requirements as outlined in the Caltrans Scenic Highway Guidelines, and therefore meets the criteria for Officially Designated State Scenic Highway status for SR 180.

Recommendation of Approval (Revised) SR 180 Officially Designated State Scenic Highway August 26, 2015

District Landscape Architecture has reviewed the County of Fresno request and reports that it is in compliance with the Scenic Highway Guidelines:

- District Landscape Architecture received a Letter of Intent from the Fresno County Board of Supervisors stating their intent to pursue Scenic Highway Designation for SR 180 (attached).
- With public participation, a VA and CPP were prepared by the County of Fresno Department of Public Works and Planning.
- The VA and CPP were submitted by Fresno County to District Landscape Architecture, and have been approved (see above web address).
- A public meeting was held by the County of Fresno Department of Public Works and Planning (attached).
- A public meeting was held by the Fresno Council of Governments (FCOG); a letter of support was submitted to Landscape Architecture by the Sierra Gateway Trust (attached).
- A public hearing was held by the Board of Supervisors; Resolution #15-030 was adopted and submitted to Landscape Architecture (attached).
- District Landscape Architecture received from Fresno County Department of Public Works and Planning a Letter of Request for State Scenic Highway Designation for SR 180.
- Neighboring Tulare County, and the United States Forest Service both endorse the recommendation for designation, and submitted written support for the designation.

Final Steps for Scenic Highway Designation:

- District Scenic Highway Coordinator recommends Official Designation to District Director for concurrence.
- State Scenic Highway Coordinator concurs and submits recommendation to Caltrans Director.
- Caltrans Director approves recommendation. Route becomes Officially Designated Scenic.
- Caltrans Maintenance staff places signs with the California Poppy logo along the Designated Scenic
 Highway. The Poppy logo identifies Designated State Scenic Highways on maps, and maps produced by the
 State Division of Tourism.


