WHEREAS, Fresno COG has partnered with ScholarDev LLC in effort to develop transit applications for several cities that make up the central Valley called **Regional Bus Transit Application (App) Project**; and

WHEREAS, SJVAPCD is a startup software company that was founded on the campus of Fresno City College and is currently based in the City of Fresno; and

WHEREAS, the will be available to the public free of charge and are intended to improve the experience of all bus riders in the central valley by providing a way to effortlessly view transit information for every bus transit system in the regions while reducing the amount of printing needed for bus schedules, and lowering the costs for both the transit agencies and the bus riders themselves; and

WHEREAS, the benefiting counties consist of San Joaquin, Stanislaus, Merced, Madera, Fresno, Kings, Tulare, and Kern

WHEREAS, the total funding request is \$51,680 from the SJVAPCD's Electronic Mobility (E-Mobility) grant program.

NOW, THEREFORE, BE IT RESOLVED, that Fresno COG, as an eligible applicant, in partnership with ScholarDev LLC, is authorized to submit the application for funding request for the Regional Bus Transit Application Project in the amount of \$51,680 for the SJVAPCD's E-Mobility Grant Program.
