EfficientGov offers grant writing assistance and provides real-time, comprehensive, grant information for all federal, state, foundation and corporate grants that are available to municipalities, counties and non-profit agencies. The database is updated daily with new grants as well as important updates to existing grants within the database. Additionally, the service provides for unlimited access to EfficientGov news, articles and the GrantIntel newsletter, which focuses specifically on grant funding.

STATE WATER RESOURCES CONTROL BOARD: WATER RECYCLING FUNDING PROGRAM (WFRP)

Deadline: December 2015 (currently accepting applications via FFAST system)

Amount: \$75,000 (for Planning Grants); \$15-\$20 Million (for Construction Grants)

Match: 25% (for Planning Grants); 50% (for Construction Grants)

Summary: The State Water Resources Control Board (State Water Board) provides funding for the planning, design, and construction of water recycling projects that offset or augment state fresh water supplies. There are two programs within this fund:

- **Planning Grants:** The purpose of the planning grant is to assist agencies or regions with completing feasibility studies for water recycling projects using treated municipal wastewater and/or treated groundwater from sources contaminated by human activities. Only local public agencies are eligible to apply for planning grants.
- **Construction Grants:** The Water Recycling Funding Program provides grants and financing to eligible applicants for the construction of water recycling facilities. Construction projects may be funded with grants and low interest financing from a state bond, a CWSRF financing agreement, or combinations of funding sources. Eligible applicants are local public agencies, nonprofit organizations, public utilities, state & federal recognized Indian tribes, and mutual water companies.

STATE WATER RESOURCES CONTROL BOARD: INTERIM EMERGENCY DRINKING WATER AND DROUGHT RELATED DRINKING WATER FUNDING APPLICATION

Summary: On March 27, 2015, Governor Brown approved a \$1 billion emergency drought relief package to take effect immediately. As a result of the Governor's action, the State Water Resources Control Board (State Water Board) approved \$19 million in funding from the Cleanup and Abatement Account to meet interim emergency drinking water needs for those communities with a contaminated water supply or that suffer drought related water outages or threatened emergencies. Eligible projects include Bottled Water; Well Repair, Well Rehabilitation, and Replacement; Vending Machines; Point of Use Devices (for example, Filtration); Hauled Water; Emergency Interties; and Treatment Systems.

FAA RESEARCH GRANTS PROGRAM

Summary: The FAA Research Grants Program encourages and supports innovative, advanced research of potential benefit to the long-term growth of civil aviation and Commercial Space Transportation. The pursuit of basic and applied research in scientific and engineering disciplines that have the potential to further knowledge and understanding on a broad front of emerging technologies is crucial to the realization of this goal. The intent is to encourage applied research and development to enhance technology assimilation, transfer, and development in the FAA. The Research Grants Program does not require the immediate application to Research, Engineering, and Development (R, E&D) programs, although this may occur in some cases. The agency encourages the submission of proposals that embrace the entire spectrum of physical, chemical, biological, medical, psychological, mathematical, and engineering sciences.

The authorizing legislation that supports the Research Grants Programs covers two general categories: a) areas deemed by the Administrator to be required for the long-term growth of civil aviation; and b) areas related to research on the prevention of catastrophic failures. These specific areas of interest may be found within the broad program areas identified in the FAA R, E&D Plan, which comprises the agency's research and development initiatives. These areas, which contribute to the FAA mission of improving aviation safety, capacity, efficiency, and security, are:

1. Capacity and Air Traffic Control Technology
2. Communications, Navigation, and Surveillance
3. Aviation Weather
4. Airports
5. Aircraft Safety Technology

6. Human Factors and Aviation Medicine
7. Environment and Energy
8. Systems Science/Operations Research
9. Commercial Space Transportation

COMMUNITY FACILITIES GRANT PROGRAM

Funding Authority:

U.S. Department of Agriculture (USDA), Rural Development

Deadline Details:

The application process and deadline vary by region. Applications are filed with the USDA Rural Development field offices. Summary: Community Programs provides grants to assist in the development of essential community facilities in rural areas and towns of up to 20,000 in population. Grants are authorized on a graduated scale. Applicants located in small communities with low populations and low incomes will receive a higher percentage of grants. Grants are available to public entities such as municipalities, counties, and special-purpose districts, as well as non-profit corporations and tribal governments. In addition, applicants must have the legal authority necessary for construction, operation, and maintenance of the proposed facility and also be unable to obtain needed funds from commercial sources at reasonable rates and terms.

Grant funds may be used to assist in the development of essential community facilities. Grant funds can be used to construct, enlarge, or improve community facilities for health care, public safety, and community and public services. This can include the purchase of equipment required for a facility's operation. A grant may be made in combination with other CF financial assistance such as a direct or guaranteed loan, applicant contributions, or loans and grants from other sources.

The Community Facilities Grant Program is typically used to fund projects under special initiatives, such as Native American community development efforts; child care centers linked with the Federal government's Welfare-to-Work initiative; Federally-designated Enterprise and Champion Communities, and the Northwest Economic Adjustment Initiative area.

Projects will be selected based on a priority point system. Projects that will receive priority are those that:

- Serve small communities - with the highest priority going to projects located in a community with a population of 5,000 or less.
- Serve low-income communities with the highest priority going to projects serving communities with median household incomes below the higher of the poverty line or 60% of the State non-metropolitan median household income.
- Provide healthcare, public safety, or public and community services

INTELLIGENT TRANSPORTATION SYSTEMS (ITS)

Summary: The U.S. Department of Transportation's (USDOT's) Intelligent Transportation Systems Joint Program Office (ITS JPO) is responsible for conducting research on behalf of the Department and all major modes to advance transportation safety, mobility, and environmental sustainability through electronic and information technology applications, known as ITS.

The USDOT's ITS program focuses on intelligent vehicles, intelligent infrastructure, and the creation of an intelligent transportation system through integration with and between these two components. The program supports the overall advancement of ITS through investments in major research initiatives, exploratory studies, and a deployment support program including technology transfer and training.

The Intelligent Transportation Systems Strategic Research Plan, 2010-2014 established a focused research agenda to prepare the next generation of ITS technologies for widespread deployment throughout the nation. At the core of the research is a multimodal initiative to enable vehicles of all types (cars, trucks, buses, trains, etc.) to communicate wirelessly with each other and with transportation infrastructure, helping to prevent potential crashes and provide other safety, mobility, and environmental enhancements.

The USDOT is working on the next ITS Strategic Plan for research in 2015 through 2019. The new plan will build on earlier ITS initiatives to continue the most promising research for achieving a connected vehicle environment and to deliver the next generation of ITS technologies to the marketplace.

The USDOT's connected vehicle research is a multimodal initiative to enable safe, interoperable networked wireless communications among vehicles, infrastructure, and passengers' personal communications devices. The USDOT and others are sponsoring connected vehicle research to leverage the potentially transformative capabilities of wireless technology to advance transportation safety, mobility, and environmental sustainability. USDOT research supports the development and testing of ITS connected vehicle technologies and applications, to determine their potential benefits and costs. If successfully deployed, connected vehicles will ultimately

enhance the safety, mobility, and quality of life of all Americans, while helping to reduce the environmental impact of surface transportation.

Research Focus Areas

Safety

According to the National Highway Traffic Safety Administration (NHTSA), there were 5.615 million crashes in 2012. The number of fatalities from vehicle crashes is falling but still accounted for 33,561 deaths. Vehicle-to-vehicle (V2V) and vehicle-to-infrastructure (V2I) wireless communications based safety applications enable vehicles to inform a driver of roadway hazards and dangerous situations that they can't see.

Mobility

According to the Texas Transportation Institute, U.S. highway users wasted 5.5 billion hours stuck in traffic in 2011. Connected vehicle mobility applications will enable system users and system operators to make smart choices that reduce travel delay. The applications will provide a connected, data-rich travel environment using information transmitted anonymously from thousands of connected vehicles in the transportation system.

Environment

According to the Texas Transportation Institute, the total amount of wasted fuel topped 2.9 billion gallons in 2011. Connected vehicle environmental applications can advise drivers on how to optimize their vehicle's operation and maintenance for maximum fuel efficiency. Data from connected vehicle ITS systems can also provide traffic management centers with detailed, real-time information on traffic flow, speeds, and other vehicle conditions. This can be used to optimize system operation.

Technology and Distraction

Safety technologies are designed to bring a driver's attention to the road or other vehicles, rather than provide additional, potentially distracting information. The USDOT's ITS program is engaged in human factors research to ensure that in-vehicle safety technologies and applications do not add to the distracted driving problem.

The Future of Connected Vehicle Safety

Based on data from the USDOT's Connected Vehicle Safety Pilot and parallel research efforts, NHTSA has made a decision to move forward with V2V communication technology for light vehicles. Later this year, NHTSA will make an agency decision on the future of the technology for heavy trucks.

NATURAL GAS VEHICLE INCENTIVE PROJECT

On Friday August 7, 2015 the California Energy Commission-funded Natural Gas Vehicle Incentive Project began accepting reservation applications for private and public non-transit. NGVIP is being administered on behalf of CEC by the Institute of Transportation Studies, at UC Irvine. The project is part of the CEC's ongoing Alternative and Renewable Fuel and Vehicle Technology Program, which has an annual budget of approximately \$100 million to support innovative transportation and fuel technologies that help California meet its energy, clean-air and climate-change goals.

ITS Irvine says NGVIP currently has an incentive budget of about \$10.2 million, and incentives are available on a first-come, first-served basis, and individual incentive amounts can vary from \$1,000 to \$25,000 depending on the gross vehicle weight, is open to individuals, firms, governmental agencies, and other entities purchasing new, eligible NGVs for use in California. LEGISLATURE CREATED CONTESTS OFFER INNOVATORS UP TO \$25,000

A trio of state department heads on Tuesday announced a set of contests in which Californians can win up to \$25,000 for ideas to improve transportation and sustainable government practices, and help prevent underage drinking. They were joined at the State Capitol by the Los Angeles lawmaker who wrote the bill creating the innovation contests.

The directors of Caltrans, the Department of Alcoholic Beverage Control (ABC) and the Department of General Services (DGS) announced the “\$25K Find a New Way” contests, which stem from legislation by Assemblyman Mike Gatto (AB 2138), which was signed into law last September by Governor Edmund G. Brown Jr.

Deadline: Tuesday, October 13, 2015 at 5:00 p.m. PDT.

Caltrans will award up to \$25,000 to the Californian with the best unique idea with the highest likelihood of being successfully put into action that will improve the state’s transportation system. All California residents are eligible to apply except for current and retired state employees and their immediate families. Applications for the Caltrans contest will be accepted beginning August 25. DGS and the Government Operations Agency will award up to \$25,000 to Californians who participate in its “GreenGov Challenge,” an open data code-a-thon to be held October 24-25, which will engage the civic coding community to better show the work the state is doing to combat climate change. Participants will focus on creating apps, visualizations, and other tools that can help improve government sustainability

practices. The contest is open to California residents and individuals who are 18 years of age or older as of the date of entry. State employees are not eligible to enter. ABC will award up to \$25,000 to the Californian(s) with the best unique idea(s) about how the department can more effectively and efficiently prevent or reduce underage drinking. All California residents are eligible to apply except for current and retired state employees and their immediate families. Applications for the ABC contest will be accepted beginning August 25.

In this second and final phase, each finalist is invited to propose specific projects that advance their community's comprehensive resilience plans.

LOW OR NO EMISSION VEHICLE DEPLOYMENT PROGRAM (LONO PROGRAM)

The Federal Transit Administration (FTA) announces the availability of \$22.5 million of Fiscal Year (FY) 2015 funds for the deployment of low or no emission transit buses. Of that amount, a minimum of \$3.0 million is available for supporting facilities and related equipment. If additional funding is appropriated for this program in FY 2016, FTA may, at its discretion, also make those funds available under this announcement.

The mission of the Corporation for National and Community Service (CNCS) is to improve lives, strengthen communities, and foster civic participation through service and volunteering. CNCS -- through AmeriCorps, Senior Corps, the Social Innovation Fund, and the Volunteer Generation Fund -- has helped to engage millions of citizens in meeting community and national challenges through service and volunteer action. AmeriCorps grants are awarded to eligible organizations proposing to engage AmeriCorps members in evidence-based or evidence-informed interventions to strengthen communities. An AmeriCorps member is an individual who engages in community service through an approved national service position. Members may receive a living allowance and other benefits while serving. Upon successful completion of their service, members earn a Segal AmeriCorps Education Award from the National Service Trust that members can use to pay for higher education expenses or apply to qualified student loans. CNCS may award a Cost Reimbursement or an Education Award Program grant to any successful applicant, but the availability of a Fixed Amount grant is limited to certain applicants. See Section II and Glossary for more information. In addition to the funding allocated for competitive distribution under this Notice, CNCS provides funding based on the population directly to Governor-appointed State Service Commissions which they, in turn, award through a process they administer according to state priorities.

In the FY 2016 AmeriCorps competition, CNCS seeks to prioritize the investment of national service resources in:

- * Disaster Services - improving community resiliency through disaster preparation, response, recovery, and mitigation
