#### 2016 Fresno COG One Voice D.C. Sponsorship Request Package

The Fresno Council of Governments and our One Voice stakeholders--elected officials, public administrators and private business executives--are currently planning the 14th Annual One Voice advocacy trip to Washington D.C. which is scheduled for April 16-21, 2016.

One Voice D.C. is Fresno COG's regional advocacy effort that assembles a public-private delegation to visit our Congressional and federal departmental representatives in Washington, D. C. The goal of the effort is to educate Members and key Administration leadership on Fresno County's regional priorities and as well as provide them with comprehensive details on the needs of Fresno County as they work to develop policy on items like transportation, water, public safety, agriculture and economic development. One Voice delegation members also benefit from the One Voice effort because they receive first-hand information on available grants and other funding that help address our regional priority needs. During the year Fresno COG also hosts sessions at which members of the state legislature and administration meet with stakeholders in the District to discuss the region's needs.

Now, more than ever, it is important to advocate for policy and regulatory reform as well as the preservation and augmentation of funding which are crucial to projects and programs in the Fresno County region. Since 2003, Fresno COG's One Voice efforts have successfully secured millions of dollars in federal appropriation funds for Fresno County. By also advocating for policy and regulatory reform, Fresno COG One Voice has had legislation introduced and enacted that today streamlines the way federal and state agencies work together. We continue to find ways to eliminate unnecessary procedures so that government agencies and the business community can work together efficiently toward job creation for our communities.

The One Voice approach is positively recognized and viewed as a means of assisting Administration representatives identify, prioritize and shepherd much needed projects and programs through the appropriation, legislative and reauthorization process. No accomplishments in connection with One Voice activities would be possible without the outstanding leadership of the Fresno region's congressional delegation.

Fresno COG's One Voice effort needs your support. We are reaching out to community and corporate sponsors to help offset costs of this effort so that we may continue the One Voice mission. Sponsorship support will help raise the visibility of unfunded transportation needs, drought conditions in the Valley, and other regional priorities that need support. Donated funds are used for One Voice expenses and do not benefit specific individuals or issue-specific expenses.
