The biggest movement of the year so far for appropriations bills highlights the week. Here's the wrap-up on that action and more for your review.

### FY17 Senate Transportation-HUD Appropriations



On Thursday, the Senate Appropriations Committee approved, by a vote of 30-0, its FY17 spending bill (S. 2844) on Transportation and the Department of Housing and Urban Development (THUD). The \$56.5 billion bill represents an overall decrease of \$827 million from FY16 levels.

The **Department of Transportation** would receive \$16.9 billion in FY17, which is a \$1.7 billion decrease from FY16. **TIGER Grants** would receive \$525 million in FY17, a \$25 million increase from FY16. The bill appropriates \$44 billion to be spent from the **Highway Trust Fund** on the Federal-aid Highways Program, consistent with the *FAST Act*. The **Federal Transit Administration** would receive \$12.3 billion in FY17, an increase of \$575 million from FY16. This includes \$9.3 billion for **Transit Formula Grants**, an increase of \$753 million from *MAP-21* levels. The **Capital Investment Grant Program**, which includes New Starts, would receive \$2.3 billion in FY17, a \$161 million increase from FY16. Within the Capital Investment Grant program, the bill allocates \$333 million for **Core Capacity Projects**, \$241 million for **Small Starts**, \$20 million for the **Expedited Delivery Pilot Program**, and \$23 million for oversight activities.

The **Federal Railroad Administration** would receive \$1.7 billion in FY17, an increase of \$76 million from FY16. Of this amount, **Amtrak** would receive \$1.42 billion in FY17, an increase of \$30 million from FY16, but about \$82 million less than the amount authorized by the *FAST Act*. The bill provides \$50 million for **rail safety activities**, \$20 million for the Federal-State Partnership for **State of Good Repair** Grants, and \$15 million for **Restoration and Enhancement** Grants.

The **Federal Aviation Administration** would receive \$16.4 billion in FY17, an increase of \$131.6 million from FY16. The bill also would provide \$1 billion for **NextGen** and fully funds the **Contract Towers** Program.

The **Department of Housing and Urban Development** would receive a total of \$39.2 billion in FY17, an increase of \$891 million from FY16. The Committee level-funds the **CDBG** program with \$3 billion for FY17. The **HOME** Investment Partnerships program would be level-funded with \$950 million for FY17. The **Homeless Assistance Grants** program would receive \$2.33 billion in FY17, an increase of \$80 million from FY16. **HUD-VASH** vouchers would receive \$50 million in FY17, a decrease of \$10 million from FY16.

The Choice Neighborhoods Initiative would receive \$80 million in FY16, a decrease of \$45 million from FY16. Tenant-Based Rental Assistance would receive \$20.4 billion in FY17, an increase of \$803 million from FY16. Project-Based Rental Assistance would receive \$10.9 billion in FY17, an increase of \$281 million from FY16. The Public Housing Capital Fund would receive \$1.925 billion in FY17, an increase of \$25 million from FY16. The Public Housing Operating Fund would receive \$4.675 billion in FY17, an increase of \$175 million from FY16. The Rental Assistance Demonstration would receive a first-time appropriation of \$4 million in FY17, and the Committee recommends increasing the current unit cap on Public Housing Conversions to 250,000. In related news, during his opening statement at the Full Committee markup, Senate Appropriations Chairman **Thad Cochran** said that Senators **Roy Blunt** and **Lindsey Graham** are working with Senators **Patty Murray** and **Patrick Leahy** to develop a bipartisan supplemental appropriations package to help combat the **Zika Virus**. The Chairman said, "It is my expectation that this proposal will be offered to an appropriations measure on the Senate floor in the near future." #### **FY17 Senate Commerce-Justice-Science Appropriations**

On Thursday, the Senate Appropriations Committee approved, by a vote of 30-0, its FY17 spending bill (S. 2837) on Commerce, Justice, and Science (CJS). The \$56.3 billion bill represents an overall increase of \$563 million from FY16 levels. The bill would provide \$1.18 billion for **State and Local Law Enforcement Assistance**, a decrease of \$225 million from FY16. The **COPS Office** would receive a total appropriation of \$215 million in FY17, an increase of \$3 million from FY16. The **COPS Hiring Program** would receive level-funding in FY17 of \$187 million. Of the \$187 million, \$30 million would be setaside as a transfer to the **Tribal Resources Grant Program**, \$10 million would be set-aside for **Community Policing Development/Training and Technical Assistance**, and \$10

million would be set-aside for the **Collaborative Reform Model**.

The State Criminal Alien Assistance Program (SCAAP) would receive \$100 million in FY17, a decrease of \$110 million from FY16. The Community Trust Initiative would receive \$70 million in FY17, which includes \$22.5 million for the Body-Worn Camera Partnership Program and \$17.5 million for the Byrne Criminal Justice Innovation Program. The Byrne-JAG Program, excluding set-asides, would receive \$348.1 million in FY17, an increase of \$1 million from FY16. The Bulletproof Vests Partnership program would receive level-funding of \$22.5 million in FY17, with \$1.5 million of that amount set-aside for the NIST Office of Law Enforcement Standards.

The **Economic Development Administration** would receive an overall FY17 appropriation of \$254 million, a decrease of \$7 million from FY16. This includes \$20 million in FY17 for the **Regional Innovation Program**. # **FY17** Energy-Water Appropriations

On Tuesday, the full House Appropriations Committee approved, by voice vote, its FY17 Energy-Water spending bill. The House bill bans EPA from implementing its **Waters of the U.S.** (WOTUS) rule. On Thursday, the Senate voted on several amendments to its FY17 Energy-Water bill (H.R. 2028). By a vote of 56-42, the Senate did not adopt an amendment that would ban EPA from implementing its WOTUS rule. Previously, the White House had issued a veto threat against the Senate's entire bill, largely due to this possible WOTUS rider. Senator **Lamar Alexander** said the bill could be passed by the Senate as early as Monday or Tuesday. A dynamic and early start to the appropriations process highlights the week, though the swift beginning does not come with any great confidence on what the conclusion will be. Lots more to talk about in the review below of a very busy week in Washington.

#### **Appropriations Mark-ups Begin**



The appropriations process for federal fiscal year 2017 (FY17) began in earnest this week with subcommittees of the House and Senate Appropriations Committees marking-up their respective spending bills

to fund specific sections of the federal government. Even though neither chamber has adopted its own overall FY17 budget framework, the Committees are moving forward under the top-line discretionary spending caps set by the *Bipartisan Budget Act of 2015* (PL 114-74). The law allows for a total of \$551.068 billion to be spent on defense programs and a total of \$518.531 billion to be spent on domestic programs in FY17. This week, the House and Senate Appropriations Committees considered their FY17 Energy-Water bills. The House bill would spend a total of \$37.4 billion, an increase of \$259 million from the FY16 level. Renewable energy programs would receive \$1.8 billion in FY17 in the House bill, a decrease of \$248 million from FY16 levels. The House bill funds the U.S. Army Corps of Engineers with \$6.1 billion, an increase of \$100 million from FY16 levels. It also includes legislative text from Rep. David Valadao's Western Water and American Food Security Act of 2015 (H.R. 2898), which seeks to provide relief for California communities that have suffered under more than five years of drought. The bill prohibits EPA from changing federal jurisdiction under the Clean Water Act, which would block the Administration's Waters of the United States rule. The Senate's FY17 **Energy-Water** bill would spend a total of \$37.5 billion, an increase of \$261 million from the FY16 level. **Renewable energy** programs would be level-funded in the Senate bill at \$2.073 billion in FY17. The Senate bill funds the **U.S. Army** 

**Corps of Engineers** with \$6 billion, an increase of \$11 million from FY16 levels. It prohibits any changes to the definition of *"fill material"* under the **Clean Water Act**. For more, click on FY17 Senate Energy-Water.

The House FY17 **Agriculture** subcommittee bill would receive a total of \$21.3 billion in discretionary funding, a decrease of \$451 million from the FY16 level. The **Supplemental Nutrition Assistance Program** (SNAP) would receive \$79.7 billion in mandatory spending, a decrease of \$1.2 billion from FY16, which the Committee says is due to declining enrollment. The **Women, Infants, and Children** (WIC) Program would receive level discretionary funding of \$6.35 billion in FY17. For more, click on FY17 House Agriculture.

Both the House and Senate have announced their FY17 **Military Construction-VA** bills. The House bill provides a total of \$81.6 billion for FY17, an increase of \$1.8 billion from FY16, while the Senate bill provides a total of \$83 billion for FY17, an increase of \$3.1 billion from FY16. Action this week on so many fronts – climate, housing, transportation, broadband, education, municipal securities, and lots more. Here's the highlights for your review.

### **Taking Action on Climate Change**



More than 50 city and county governments from 27 states have signed an amicus brief, which was filed with the DC Circuit Court of Appeals, explaining why the EPA's **Clean Power Plan** is critical to the safety and economic

security of local communities across the United States. The local government signatories view the Clean Power Plan as a "legally necessary step toward addressing the extraordinary threat posed by climate change." In 2015, more than two dozen Mayors sent a letter to President Obama urging him to "provide a path forward to make meaningful reductions in carbon pollution while preparing for the impacts of climate change." More than 125 U.S. cities have already committed to the Compact of Mayors, a global coalition of more than 460 Mayors pledging to reduce their greenhouse gas emissions, track their progress transparently, and enhance their resilience to climate change. Of the 52 local governments signed onto the brief, more than half are committed to the Compact. For more, click on Cities and Counties Amicus Brief.

On Monday, the White House released a new final report titled *The Impacts of Climate Change on Human Health in the United States: A Scientific Assessment*, which significantly advances what we know about the impacts of climate change on public health, and the confidence with which we know it. The report was developed over three years by approximately one hundred experts in climatechange science and public health. # FCC Modernizes Lifeline Broadband Program

By a vote of 3-2, the Federal Communications Commission (FCC) approved an order to modernize the Lifeline program, which helps low-income consumers afford broadband internet access. Historically, Lifeline supported broadband only if it was bundled

with a voice and data plan, but now consumers will have access to stand-alone broadband services. The rule sets a budget of \$2.25 billion, indexed to inflation, which will allow for increased participation generated by support for broadband service. # **Justice Department Equitable Sharing Program Resumes**

The Justice Department announced that, effective immediately, the Department is resuming Equitable Sharing payments to State, local, and tribal law enforcement agencies. Through the Equitable Sharing Program, the Department distributes an equitable share of forfeited property and proceeds to participating state and local law enforcement agencies that directly participate in an investigation or prosecution that result in federal forfeiture. # Municipal Securities Boosted by the Fed

The Federal Reserve Board finalized a rule, scheduled to take effect **July 1**, that allows some state and municipal securities (such as municipal bonds) to be counted as High-Quality Liquid Assets (HQLA), which large banking organizations must hold to meet their Liquidity Coverage Ratio (LCR) requirements. #### **Improving Public Housing**

On Monday, HUD announced that nearly \$174 million will soon be made available through first-ever allocations of the **National Housing Trust Fund**. HUD expects to make individual allocations to States later this spring and anticipated these funds can be drawn upon as early as this summer. This new affordable housing production program will help to increase and preserve the supply of decent, safe, and sanitary affordable housing for extremely low- and very low-income households, including families experiencing homelessness. Under the FY16 Omnibus Appropriations law, HUD is authorized to expand the **Moving to Work** demonstration by an additional 100 public housing authorities (PHAs) over seven years, an increase from the current number of 39 PHAs. HUD is soliciting recommendations for specific policy proposals and

methods of research and evaluation to be implemented as part of the MTW expansion. Comments are due by **May 4**. For more, click on MTW Expansion or HUD Request for Comments.

HUD announced that, three years after its launch, the **Rental Assistance Demonstration** has generated \$2 billion in private investment to make critically needed repairs and improvements to more than 30,000 units of former public housing. # Surface Transportation in the Spotlight

On April 1, more than 300 local, state, and federal government officials, health experts, and non-government partners gathered at the Centers for Disease Control and Prevention (CDC) headquarters to

prepare for the likelihood of mosquito-borne transmission of the Zika virus in some parts of the continental United States. Puerto Rico, the U.S. Virgin Islands, and American Samoa already are experiencing active Zika transmission. The ZAP Summit aimed to identify gaps in readiness and provide technical support to states in the development of Zika action plans that will allow their jurisdictions to effectively prepare for and respond to active Zika transmission they may experience. On Thursday, OMB Director **Shaun Donovan** announced that the Administration will quickly redirect \$589 million in existing federal funding to be spent on immediate, time-critical activities such as mosquito control, lab capacity, development of diagnostics and vaccines, and other

measures. The Administration continues to request that the House Appropriations Committee approve \$1.9 billion in emergency supplemental FY16 funding to combat the spread of the Zika virus. Currently, the Speaker has a number of policy task forces made up of committee leaders and members, working on cross-cutting issues. Those task forces will report in May and cumulatively their work will represent the House leadership agenda going forward. # **Focusing on Education**

The Education Department sent proposals to the committee working on proposed regulations for the *Every Student Succeeds Act (ESSA)*. The proposals focus on the issues being negotiated by the committee: (1) Title I, Part A assessments; and (2) the requirement that federal Title I-A funds supplement, not supplant, state and local resources. # U.S. DOT on Connecting People to Opportunity



This week, Transportation Secretary **Anthony Foxx** put forth a vision to address the divide between low-income, minority neighborhoods and wealthier, whiter neighborhoods, that was caused, in part, by misguided

infrastructure planning decisions made decades ago. He said, "What previous decision-makers thought of poor and minority communities was reflected in where and how they built our transportation infrastructure – certain values of that time are still embedded in that infrastructure today." The Secretary introduced his vision to the Rotary Club in Charlotte, North Carolina on Tuesday, where he previously served as Mayor, followed by a presentation at the Center for American Progress on Wednesday.

The Secretary called on transportation planners at the federal, state, and local levels to embrace three Fundamental Principles for Connecting People to Opportunity: (1) Transportation connects people to opportunity and can invigorate opportunity within communities. To the greatest extent possible, we should support transportation projects that do both; (2) While we cannot change the past, we can ensure that current and future transportation projects connect and strengthen communities, including areas that have, in the past, been on the wrong side of transportation decisions; and (3) Transportation facilities should be built by, for, and with the communities impacted by them. Development of transportation facilities should meaningfully reflect and incorporate the input of all the people and communities they touch. A bi-partisan group of Governors and Mayors have already signaled their support for these principles. # National Rx Drug Abuse and Heroin Summit



On Tuesday, we participated in a White House teleconference with ONDCP Director **Michael Botticelli** and HHS Assistant Secretary for Planning and Evaluation Dr. **Richard Frank** to learn more about additional steps

the Administration is taking to address the prescription opioid abuse and heroin epidemic. Later that day, President Obama spoke at the National Rx Drug Abuse and Heroin Summit in Atlanta, which was organized by House Appropriations Chairman Hal Rogers. Chairman Rogers said, "I'm grateful that despite the many challenges confronting our nation at home and abroad, that the President has made this issue a priority and is here to talk with us today about the problem." The President announced that HHS is issuing a proposed rule to increase the current patient limit for qualified physicians who prescribe buprenorphine to treat opioid use disorders from 100 to 200 patients with the goal of expanding access to this evidence-based treatment while preventing diversion. Additionally, CMS if finalizing a mental health and substance use disorder parity rule for Medicaid and CHIP. # **Repurposing Old Transportation Earmarks**



The Federal Highway Administration (FHWA) has released guidance giving state DOTs the option of repurposing certain earmarked federal funds if the original earmark was over 10 years old and if one of the following conditions apply:

(1) less than 10 percent of project funds have been obligated, or (2) more than 10 percent of project funds have been obligated and the project is closed.

Through September 30, 2016, state DOTs have the option of redesignating these dollars to other projects within 50 miles of the originally intended use. A state opting to do so must work with their FHWA Division office to ensure that US DOT is notified of the repurposing by August 29th or earlier in the case of some projects. Obligations for requests received in FY16 must be obligated by September 30, 2019.

#### The Affordable Care Act Turns Six

President Obama signed the *Patient Protection and Affordable Care Act* (PL 111-148) into law on March 23, 2010, and the White House used the law's sixth anniversary to highlight some of its accomplishments. Under the ACA, an estimated 20 million people have gained health insurance coverage, and the White House says that more than 90% of Americans are covered. The law prohibits coverage denials and reduced benefits for as many as 129 million Americans who have some type of pre-existing health condition. Community Health Center grantees have received \$11 billion since the law was enacted, and served 23 million patients in 2014. #### Speaker Ryan on the State of American Politics



Wednesday, House Speaker Paul Rvan delivered an address on the troubled state of American politics to a group of House interns from both sides of the aisle. He argued for improvement, noting that politics must be

about uniting people around principles and specific ideas – not impugning motives and playing to anxieties and fear. "Politics can be a battle of ideas, not insults. It can be about solutions. It can be about making a difference. It can be about always striving to do better," he said. The speech was given in the context of Speaker Ryan's Confident America initiative, an attempt to create a unifying policy agenda for House Republicans. # **EPA Administrator on Drinking Water**



On Monday, EPA Administrator Gina McCarthy delivered the keynote address at the Association of Metropolitan Water Agencies' 2016 Water Policy Conference. She discussed international climate change initiatives as well as the

need for better water infrastructure nationally. She said that the White House is spearheading a national effort "that is looking at issues of infrastructure." On the EPA's responsibility in the leadup to the water crisis in Flint, she said that, "I think it's safe to say that nobody at EPA ever imagined that a city would decide to trade

treated water for untreated source water, and then fail to treat it... [Our] relationship [with our state partners] failed in this instance and we cannot be too trusting of the system." She told the audience that she was committed to not let a tragedy like the Flint crisis happen again on her watch, and argued that water systems need to rely on more than just the money in SRF to solve the bigger infrastructure issues. **FY17 Appropriations Process Begins** 

On Wednesday, the House Military Construction-VA Subcommittee approved its FY17 spending bill by voice vote, the first FY17 appropriations measure to be approved this year. Congressional appropriators are beginning their FY17 work at the subcommittee level without a budget resolution being passed by either chamber. House Appropriations Chairman Hal Rogers may ultimately give his subcommittees a total national discretionary spending limit of \$1.07 trillion, which complies with the Bipartisan Budget Act of 2015. The House plans to continue consideration of its budget resolution (H. Con. Res. 125) after its members return on April 12.

While the House Budget Committee's resolution adheres to the \$1.07 trillion level, House conservatives are demanding that it includes an amendment that would cut mandatory spending levels by \$30 billion in FY17, which would be in line with spending levels under the Budget Control Act of 2011 (PL 112-25). Under the Budget Act of 1974, without a budget resolution in place to establish enforceable spending limits, the House must typically wait until after May 15 to bring spending bills to the floor, unless that rule gets waived. #### President Obama's Historic Trip to Cuba

Earlier this week, President Obama and the First Family traveled to Cuba, the first visit to the country by an American President since President Calvin Coolidge traveled to Cuba on a U.S. battleship in 1928. The visit marked an historic milestone since President Obama and Cuban President Raul Castro

announced that the two countries would begin to normalize relations 15 months ago. The Commerce Department released a Fact Sheet showing how federal agencies have changed regulations to allow increased economic development in Cuba since then. Cuba is close, so there could be an impact in your city as engagement continues and grows. #### **Fighting Heroin and Opioid Abuse**

On Tuesday, the House Oversight and Government Reform Committee held a hearing titled "America's Heroin and Opioid Abuse Epidemic," featuring witness testimony from ONDCP Director **Michael Botticelli**, among others. The purpose of the hearing was to examine the strategies of the Office of National Drug Control Policy, and the Substance Abuse and Mental Health Services Administration to address opioid abuse. The President will travel to Atlanta on Tuesday, where he will speak at the *National Rx Drug Abuse & Heroin Summit*, an annual summit that is the largest national collaboration of professionals and advocates impacted by prescription drug abuse and heroin use. The President's FY17 budget proposal includes \$1.1 billion in new funding – most of which would go directly to states – to increase the availability of treatment options for those who seek it. # The Diaper Divide

Earlier this week, we discussed the Administration's new initiative to close the "Diaper Divide" with Josh Miller of the White House Office of Digital Strategy and Luke Tate of the Domestic Policy Council. The White House estimates that lowincome families spend as much as 14 percent of their annual income, or approximately \$936 per year per child, on diapers. Nearly 1 in 3 American families struggle with this expense, which is causing serious public health concerns for both the children and their parents. Unfortunately, there is no federal assistance available for this cause, so the Administration has partnered with online merchant Jet and the National Diaper Bank Network, a nonprofit organization, to address the disparity. Jet will provide diapers to local nonprofit organizations and diaper banks at a price of 13 cents a unit, which is much lower than the retail average of 33 cents. President Obama announced the public-private partnership during his remarks at the South by Southwest festival last Friday.
