Fresno Council of Governments Monthly State Legislative Report July 2016

According to State law, August 31st of each even year is the last day for the Legislature to pass bills in a regular two-year session, except for bills that take effect immediately (such as bills with urgency clauses and tax levies) or bills in an Extraordinary Session. The Legislative deadline for policy committees to hear bills in either house is July 1st. Because this is the second year of the two-year session, any bills not heard and reported out of policy committee in their house of origin are generally considered to be "dead". The Legislature adjourned for Summer Recess at the end of June and will not return until Monday, August 1st.

Most bills that emerge from policy committees are referred to each house's respective Committee on Appropriations, where they will be placed on the Suspense File if anything more than minor costs are associated with them. The final Suspense hearings will likely occur the week of August 8.

The \$167.6-billion 2016-17 Budget Bill was approved by the State Legislature on Wednesday June 22nd. It provides for an increase of approximately \$7 billion in General Fund spending over the current year budget and prepares for future economic downturn with a \$2 billion supplemental deposit in the State's Rainy Day Fund. The new spending plan includes a \$115.4-billion general fund and takes effect July 1. However, it does not include significant transportation reforms or sustainable funding at this time and the Governor stated that he is confident that transportation funding will be addressed/resolved by the special session immediately. The special session has included discussions of possible tax increases and fees to pay for current and additional spending. Furthermore, the budget does not include a plan for using the millions of dollars generated by the cap and trade program. Lawmakers have differentiating ideas of how to use these competitive funds, which are less than originally expected.

A Heartbreaking Week

What a heartbreaking week for our country in Baton Rouge, St. Anthony, and Dallas – the stories are different but the combined news is horrific. We all hope for better days in America. President Obama's statements on the shooting in Dallas and the shootings in Louisiana and Minnesota speak for us all about our national agony and the road ahead.

Below, for your review, are the highlights of this week's White House, agency, and congressional developments.

Funding to Reduce Opioid Abuse Debated

On Wednesday, the White House announced additional actions to expand access to treatment, strengthen prescription drug monitoring, enable safe disposal of unneeded drugs, and accelerate research on pain and opioid misuse and overdose. HHS is issuing a final rule to increase from 100 to 275, starting on August 5, the number of patients that qualified physicians who prescribe buprenorphine for opioid use disorders can treat. Buprenorphine is a medication used to treat heroin addiction, which acts on the same receptor targets of heroin and other opioids, but does not produce the same intense high or dangerous side effects. HUD, in partnership with HHS and the U.S. Interagency Council on Homelessness, is identifying best practices to support individuals using medication-assisted treatment in programs funded through HUD's Homeless Assistance Grants to promote replication of best practices throughout the country. House and Senate conferees met Wednesday to negotiate the provisions of the *Comprehensive Addiction and Recovery Act of 2016*. Democrats offered amendments to provide \$940 million in new spending, which were not adopted. Senator **Patty Murray** said, "I am very concerned that if we pass a bill that changes our nation's opioid policies, but completely ignores the funding that would enable cities and states to put those policies into practice, that funding might never come." Today, the House approved the Conference Report by a vote of 407 to 5. For more, click on House-Senate Opioid Conference Report Finalized or Democrats' Statement.

Bills Against Sanctuary Cities Fail in the Senate

On Wednesday, the Senate failed to reach the 60 votes necessary to move forward on two bills that would have penalized so-called "Sanctuary Cities" that have adopted policies limiting information sharing with immigration offices. The *Stop Dangerous Sanctuary Cities Act* (S. 3100) would have denied CDBG and EDA funding to sanctuary cities. The *Establishing Mandatory Minimums for Illegal Reentry Act* (S. 2193) would have imposed new mandatory minimum sentences for illegal reentry offenses. House Indefinitely Postpones Gun Control Bill

On Thursday, House GOP leadership aides told reporters that they have indefinitely postponed a vote on an anti-terrorism bill (H.R. 5611), that would have included an amendment to curb gun sales to those suspected of having ties to terrorist organizations and create a new office at the Department of Homeland Security to support an anti-terrorism initiative. House Democrats continue to push for stronger gun control legislation. We will update you with any new movement on gun control.

Data-Driven Justice Initiative



To break the cycle of incarceration faced by millions of low-risk non-violent offenders every year, the White House is launching the Data-Driven Justice Initiative (DDJ) with a bipartisan coalition of 67 city, county, and state governments. These jurisdictions are

committed to using data-driven strategies to divert low-level offenders with mental illness out of the criminal justice system and change approaches to pre-trial incarceration, so that low-risk offenders no longer stay in jail simply because they cannot afford a bond. Speaking during the announcement, Salt Lake County Mayor Ben McAdams said, "We joined the Data-Driven Justice Initiative because we've seen that that there are people in our county jails that quite simply don't need to be there." The County has partnered with the University of Chicago to determine the best ways to solve the immediate problems, and tackle the long-term root causes. It provides \$9.78 billion to the **Employment and Training Administration**, a decrease of \$257 million. **CDC** would receive \$390 million specifically to fight the **Zika virus**.

Head Start would receive \$9.3 billion, an increase of \$142 million. It provides \$67 billion to the **Department of Education**, a decrease of \$1.3 billion, which includes \$12.4 billion for **IDEA** special education grants to states, a \$500 million increase. With the number of working legislative days dwindling in Congress to approve regular FY17 appropriations bills, discussion is rapidly intensifying on the need to pass an extension of current funding through a Continuing Resolution (CR). A group of House Republicans is pushing hard for a vote next week on a six-month CR, at the current FY16 base discretionary spending level of \$1.067 trillion, which would last until March 2017. This would effectively punt major spending negotiations to the next Congress and the next President. The FY17 discretionary spending cap is \$1.07 trillion. We'll update you on the latest appropriations action.

DHS Countering Violent Extremism and FY16 Preparedness

FEMA and the DHS Office for Community Partnerships announced that they are accepting applications for the FY16 Countering Violent Extremism (CVE) Grant Program. The purpose of the program is to develop and expand efforts at the community level to counter violent extremism recruitment and radicalization to violence. DHS will award approximately \$10 million in total program funding through up to 60 grants, ranging from \$20,000 to \$1.5 million each. FAA Reauthorization Through FY17

With the current authorization of the Federal Aviation Administration (FAA) set to expire on July 15, on Wednesday, leaders of the House Transportation and Infrastructure (T&I) Committee and the Senate Commerce, Science, and Transportation Committee announced that they had agreed to extend spending authority for the FAA through September 30, 2017, which is the end of FY17. The extension includes several aviation safety and security provisions, but it does not include a provision championed by House T&I Chairman **Bill Shuster** that would have spun off FAA's air traffic control responsibilities into a nonprofit entity.

Any week in which Mayors meet with the Dalai Lama and Lady Gaga at the same time is a memorable one – and there's a lot more news as well! Here's the highlights for your review.

U.S. Conference of Mayors 84th Annual Meeting



We attended the 84th Annual U.S. Conference of Mayors meeting in Indianapolis, Indiana last weekend. Mayor **Jim Brainard** kicked off the Conference in style with a remarkable

event at the Palladium and Center Green in Carmel on Friday. The Conference featured many notable presentations including from presumptive Democratic nominee former Secretary of State Hillary Clinton, His Holiness the 14th Dalai Lama, singer and artist Lady Gaga, journalist Ann Curry, and Libertarian candidate Gary Johnson.

During the four-day gathering, more than 200 city leaders met to discuss a broad range of policy issues impacting America's cities and their economic health, including community policing, federal investment in America's cities, and public-private partnerships that drive innovation and efficiency. Oklahoma City Mayor **Mick Cornett** was appointed by the Conference to serve as its 74th President for the June 2016-June 2017 term. In his inaugural remarks, Mayor Cornett spoke about infrastructure investment, healthy living and wellness, criminal justice reform, technology, and the strength of U.S. cities and metropolitan economies.

At the concluding session of the Conference on Monday, the Mayors debated and voted on policy recommendations to present to the Administration. The Conference approved resolutions in support of Criminal Justice Reform, funding to combat the Zika virus, legislation to fight opioid addiction, direct funding to cities to combat poverty, comprehensive investment in rebuilding the nation's infrastructure, water infrastructure, ending the U.S. embargo against Cuba, and many other topics. Orlando Mayor **Buddy Dyer** spoke to the Conference and thanked the Mayors for their support in the wake of the horrendous shooting at the Pulse Nightclub. He told the Mayors, "It's clear to me that we live in a new world, a world that any one of our cities could be the site of this kind of intentional mass-casualty event."

Hillary Clinton followed shortly after Mayor Dyer ended his remarks. She spoke about the ongoing problem of gun violence in America, recalling her 2015 speech to the Mayors that occurred soon after the murders in Charleston. She spoke about ending partisan gridlock, ending homelessness, improving education, support for the New Markets Tax Credit program, and other issues.

In a roundtable discussion, His Holiness the **Dalai Lama** and artist **Lady Gaga** spoke about the need for more kindness and compassion. The Dalai Lama said, "America should be the leading nation in the world for the promotion of human compassion, and human love, in order to achieve a more compassionate world." Lady Gaga told the Mayors, "The most efficient way for you to act with the young people in your cities is to be a calming force in their lives." Appropriations Process Remains Shaky

This week, the Senate failed to move forward on approving a conference report on an FY17 appropriations measure, H.R. 2577, that bundles funding for Military Construction-VA with a bipartisan \$1.1 billion response to combat the Zika virus. The inability for Congress to move forward on this and other annual spending measures, largely due to controversial amendments added to these bills, raises serious questions about how both chambers plan to proceed once they return for two weeks of work after Independence Day. We will continue to closely monitor progress on appropriations work.

House GOP Policy on Tax Reform

As the sixth and final plank of his, "A Better Way," policy proposals, House Speaker Paul Ryan unveiled a House GOP blueprint on tax reform. The plan would lower the top corporate tax rate from 35 percent to 20 percent. For individual income taxes, the current seven tax brackets would be collapsed into three, with the top individual tax rate being lowered from 39.6 percent down to 33 percent. Tax-deferred offshore cash would be subject to an 8.75 percent tax, while real estate and other "brick and mortar" overseas holdings would be taxed at 3.5 percent. The child tax credit would be expanded to \$1,500, of which \$1,000 would be refundable. For more, click on House GOP Tax Reform Proposal.

HUD Choice Neighborhoods Grant Winners

As you read this, we are at the U.S. Conference of Mayors Annual Meeting in Indianapolis (with a kick-off in Carmel) with a number of key speakers, including former Secretary of State Hillary Clinton, the presumptive Democratic nominee for President. We'll report on all that for you next week. Meanwhile, here's the highlights from a busy week in Washington, for your review.

Gun Control Debate Takes Center Stage



It has been an historic week in Congress as the Senate was finally able to hold four votes on gun-related measures while Democrats held a 25.6 hour-long sit-in in the House of Representatives to demand a vote on gun measures in their chamber. Senator **Chris**

Murphy's filibuster on the Senate floor last week lasted for 14.8 hours. On Monday evening, the Senate did not approve any of the two Democratic or two Republican gun-related amendments to the FY17 Commerce-Justice-Science appropriations bill. In the wake of the failure to win approval of those amendments, Senator Susan Collins has spearheaded a bipartisan amendment called the Terrorist Firearms Prevention Act of 2016, which would give the Attorney General the authority to deny firearms sales to individuals who appear on the No Fly List or the Selectee List, and provides a process for Americans and green card holders to appeal a denial in the U.S. Court of Appeals and to recover their reasonable attorney fees if they prevail, among other provisions. On Thursday, a motion to table Senator Collins' amendment failed by a vote of 46-52, keeping the measure viable. On Wednesday, at about 11:30am, Congressman **John Lewis** initiated a sit-in with fellow House Democrats, which lasted until about 1:00pm on Thursday. The move forced House Speaker **Paul Ryan** to cancel scheduled votes on Wednesday. Votes took place on Thursday between 1:00am and 3:11am on measures not related

to gun control. Soon after, the Speaker started a recess in the House which will last until the morning of July 5. The dramatic action by House Democrats stalled House progress on appropriations bills but drew national attention to the issue of gun regulation. For more, click on Video of Rep. Supreme Court Rejects Obama Immigration Actions

On Thursday, a split 4-4 ruling from the Supreme Court left in place the lower court rulings that halted implementation of President Obama's executive actions on immigration. The oneline ruling from the Supreme Court reads, "The judgment is affirmed by an equally divided Court." It is as though the Court never heard the case. President Obama tried to reassure the millions of undocumented immigrants left in limbo by the decision, saying, "People who might have benefited from the expanded deferred actions policies, long-term residents raising children who are Americans or legal residents, they will remain low priorities for enforcement." The Deferred Action for Childhood Arrivals program (DACA), in which more than 500,000 individuals have enrolled since 2012, was not involved in the court case and remains in place. FY17 Appropriations Update

With few days remaining on the Congressional calendar, and issues like gun control and the Iran deal slowing the appropriations process, lawmakers from both sides of Capitol Hill are predicting the passage of another short or long-term Continuing Resolution (CR) for FY17, to keep the federal government open after September. On Tuesday, House Democratic Whip **Steny Hoyer** said that Democrats would like a CR to last from October to December, followed by an omnibus spending bill for the rest of FY17. Some conservative House members are calling for a CR to last until March 2017. Senate Majority Leader **Mitch McConnell** said that he intends to stick to his plan of passing bills through regular order and will stack the summer schedule with regular appropriations work. The nation's debt limit is suspended until March 15, 2017.

On Wednesday, the House Appropriations Committee approved its \$41.1 billion Homeland Security spending bill, which includes an additional \$49 million to counter violent extremism and plan for large-scale terror attacks. On Thursday at 3:10am, the House approved its FY17 Military Construction-VA spending bill by a vote of 239-171, which includes a \$1.1 billion **Zika Virus** response package. President Obama, who has long advocated for Congress to approve a \$1.9 billion FY16 emergency supplemental appropriation to combat Zika, has

Small Unmanned Aircraft Regulations Finalized



On Tuesday, the Federal Aviation Administration (FAA) finalized the first operational rules for routine commercial use of small unmanned aircraft systems (UAS or "drones"). Pilots will be required to keep an unmanned aircraft within visual line of sight.

A good deal of activity on lots of fronts this week, all of which pale in light of the horrific murders in Orlando. We'll lead with that this week and follow with some of the highlights from the White House, agencies, and Congress.

Tragedy in Orlando



This week, our hearts were with the people of Orlando, who experienced the deadliest mass shooting on U.S. soil in modern times. Our friend, Orlando Mayor **Buddy Dyer**, wrote in a letter to fellow Mayors, "This past Sunday was the most horrific day in the history of the City of Orlando. And yet, I have never been more proud of our

community because of the way they have come together, united with a singular focus of supporting the families and friends of the victims." Senate to Vote on Gun Control Amendments

On Wednesday, at 2:11am, Connecticut Senator Chris Murphy yielded the floor of the Senate after engaging in a nearly 15-hour long filibuster, which successfully pressured Senate leaders to allow votes to occur on two Democratic and two Republican gunrelated amendments. The Senate is scheduled to vote on the amendments to the FY17 Commerce-Justice-Science bill on Monday afternoon. Senator Murphy's amendment would require universal background checks on every firearm sale and ensure that all individuals who should be prohibited from buying a firearm are listed in the National Instant Criminal Background Check System (NICS). Senator Chuck Grassley's amendment would add additional mental health considerations to firearms background checks and boost funding for NICS. Senator Dianne Feinstein's amendment would block the sale of guns or explosives to known or suspected terrorists. Senator John Cornyn's amendment, the SHIELD Act, would block the sale of a weapon to a known or suspected terrorist after a judicial process has taken place. FY17 Interior-Environment Appropriations

On Thursday, by a party line vote of 16-14, the Senate Appropriations Committee approved its FY17 Interior-Environment spending bill. The \$32.03 billion bill represents a decrease of \$125 million from the FY16 level. It provides \$1.35 billion for **Clean Water State Revolving Funds**, a decrease of \$44 million from FY16 levels. It provides \$1.02 billion for **Drinking Water State Revolving Funds**, an increase of \$157.5 million from FY16 levels. The bill includes \$400 million for **Land and Water Conservation Fund (LWCF)** programs, a decrease of \$50 million from FY16. It includes an appropriation of \$30 million in FY17 for the new **Water Infrastructure Finance and Innovation (WIFIA)** program.

The Environmental Protection Agency (EPA) would receive an FY17 appropriation of \$8.1 billion, a decrease of \$31.2 million from FY16. The bill prohibits EPA from implementing its Waters of the United States (WOTUS) rule. The National Park Service would receive \$2.74 billion, an increase of \$68 million from FY16. The National Endowment for the Arts (NEA) and the National Endowment for the Humanities (NEH) would each receive \$148 million in FY17, an increase of \$500,000 for each endowment from FY16. The bill provides \$480 million for the Payment in Lieu of Taxes (PILT) program, an increase of \$28 million from FY16. For more, click on FY17 Senate Interior-Environment or Markup.

On Wednesday, by a vote of 31-18, the House Appropriations Committee approved its FY17 Interior-Environment spending bill, which we covered in the May 27 *Friday Report*. The House bill includes an amendment by Rep. **David Valadao** that directs the use of existing regulatory flexibility to maximize water deliveries to areas of California most hard-hit by the drought. Also on Wednesday, the House and Senate Appropriations Committees held a joint Conference Committee to officially open the process of negotiating a compromise on funding to fight the **Zika Virus**. District Court Upholds Net Neutrality Rules

On Tuesday, the U.S. Court of Appeals for the District of Columbia Circuit voted 2-1 to uphold the FCC's Open Internet rules that preserve the principles of net neutrality. The rules allow broadband internet to be classified as a telecommunications service. This enables FCC to regulate broadband internet service as a utility. What a week – plans proposed, nominations gained, bills passed, and an American hero departs. Here's all the highlights for your review from a week to remember.

House GOP "A Better Way" Policy Proposals



As we previewed in last week's *Friday Report*, on Tuesday, House Speaker **Paul Ryan** released the first of six detailed policy proposals that align with the House Republican agenda, which together have been branded as "A Better Way." Tuesday's report on Poverty says that the federal government "needs to

build public-private partnerships to bring out the best of what each sector has to offer." It identifies 80 federal programs with overlapping missions that are administered by 13 federal agencies to provide food, housing, health care, job training, education, energy assistance, and cash to low-income Americans. The plan supports social impact financing and calls for stronger work requirements under the TANF program. On Thursday, House Republicans released a plan on National Security. The plan proposes that we work to close security gaps in our transportation systems to prevent Islamist militants from reaching the U.S. It calls for modernizing the military, improving intelligence-gathering for law enforcement agencies, and defeating terrorists overseas. Appropriations Update

On Tuesday, the Senate Appropriation Committee's Labor-HHS-Education Subcommittee approved its \$161.9 billion FY17 spending bill, an overall decrease of \$270 million from FY16. **Head Start** would receive \$9.2 billion, an increase of \$35 million. **LIHEAP** would receive level-funding of \$3.39 billion. **CCDBG** would receive \$2.8 billion, an increase of \$25 million. **Community Health Centers (CHC)** would receive level-funding of \$1.49 billion. The **Substance Abuse and Mental Health Services**

Administration (SAMHSA) would receive \$261 million, an increase of \$126 million, targeted to programs that combat opioid abuse.

The bill provides level-funding of \$100 million for DOL's **Apprenticeship** program. **YouthBuild** would receive level-funding of \$84.5 million. Under *ESSA*, **Title I Grants** to Local Education Agencies would receive \$15.4 billion, a \$500 million increase. **Charter School** grants would receive \$343 million, an increase of \$10 million. The **Promise Neighborhoods** program would receive level-funding of \$73.2 million. The **Corporation for National and Community Service**, which runs AmeriCorps, would receive \$1.03 billion, a decrease of \$65 million. For more, click on **FY17 Senate Labor-HHS-Education**.

On Wednesday, the House Appropriations Committee's Homeland Security Subcommittee released its \$41.1 billion FY17 spending bill, an overall increase of \$100 million from FY16. The bill provides level-funding of FEMA's **Preparedness Grants** at \$2.6 billion, including \$1.3 billion for **State and Local Grants**, \$690 million for **Firefighter Assistance Grants** (with equal amounts of \$345 million for **SAFER** and **AFG**), and \$350 million for **Emergency Management Performance Grants**. TIGER and FAST Act Implementation

U.S. DOT announced that, for the 2016 round of the TIGER program, it has received 585 applications from across the country totaling \$9.3 billion in requested funding – over 18 times more than the \$500 million that will be awarded. During this eighth year of the program, the Department received 337 applications from urban areas and 248 applications from rural communities. On Wednesday, Transportation Secretary **Anthony Foxx** testified to the Senate Commerce Committee on implementation of the *FAST Act*'s provisions. Reducing Opioid and Heroin Abuse

Though it was the week of the Congressional Memorial Day Recess, there was still lots of activity on both ends of Pennsylvania Avenue. Here's the highlights for your review.

Deal for 50% Jump in LIHTC

On Wednesday, we learned that Senator **Maria Cantwell** had cut a deal with Senate Finance Chairman **Orrin Hatch** on a proposal to expand the Low-Income Housing Tax Credit (LIHTC), by increasing state allocations by 50%, at an estimated cost of \$4.1 billion over 10 years. No state would receive less than \$4 million. Senator Cantwell's bill could move as part of the larger "miscellaneous tax bill" being considered in the House. House Ways and Means Committee Chairman **Kevin Brady** previously told reporters that he and other top House tax-writers are considering crafting a "miscellaneous tax bill" that would bundle stand-alone tax measures to benefits businesses, individuals, and local governments. No decisions have been made on the timing or content of such legislation, but the overall idea has gotten approval from Senate Finance Committee Chairman **Orrin Hatch**. The LIHTC deal would be part of this package.

Throughout June, House Speaker **Paul Ryan** plans to release six detailed policy papers focused on poverty, taxes, healthcare, national security, regulations, and constitutional authority. For more, click on <u>Speaker Ryan: A Better Way</u>.

Army Corps WOTUS Decisions Can Be Challenged



On Tuesday, by a vote of 8-0, the Supreme Court of the United States ruled that wetlands determinations by the U.S. Army Corps of Engineers can be challenged in court. More specifically, the

Supreme Court clarified that landowners and other interested

parties can go to the federal courts to challenge the Corps' jurisdictional determinations under the Clean Water Act.

Challenges of Zika Virus Testing



On Tuesday, the Centers for Disease Control and Prevention (CDC) released a report highlighting the challenges of using testing to reliably diagnose a person with the Zika Virus. For example, a positive rRT-PCE test

confirms Zika, but a negative one doesn't rule it out. More testing is required, and even that can not necessarily sort out Zika antibodies from antibodies related to previous infection with, or vaccination against, dengue or related flaviviruses, which also include West Nile, Japanese encephalitis and yellow fever. FTA plans to issue the NPRM on Transit Worker Assaults in accordance with a requirement in the FAST Act to establish "rail and bus safety standards, practices, or protocols" for "protecting rail and bus operators from the risk of assault." Both the dialogue and the webinar will be open to the public, but FTA anticipates significant interest and encourages participation from unions, transit employees, state Departments of Transportation and State Safety Oversight Agencies. National Traffic Volume Trends

New data from U.S. DOT show that U.S. driving reached 746 billion miles in the first three months of 2016, beating the previous record of 720.1 billion miles set last year. In fact, Americans as a

whole drive twice as far on any given day before noon as the International Space Station has ever flown. In March, traffic in the Northeast region – stretching from Maine to Pennsylvania – led the nation with a 6.4 percent increase in traffic, as measured by unadjusted vehicle-miles-traveled. Dedicated Tax for DC Region's Metro System



We thought you would be interested in efforts on the part of the Washington region to achieve a dedicated tax for the Metro system. The Metropolitan Washington Council of Governments (MWCOG) and the Greater Washington

Board of Trade have teamed up to organize several "summits" for this spring and summer to bring regional stakeholders together to reach a consensus on a dedicated funding plan for Metro by the fall. Any permanent funding plan would ultimately need to be approved by the District of Columbia's City Council as well as state legislatures in Annapolis, Maryland and Richmond, Virginia. D.C. Councilmember **Jack Evans**, who is Metro's board chairman, believes the best solution would be for Virginia, Maryland, and the District to raise their sales taxes to 7 percent to create a dedicated funding stream. The President remarked, "Elkhart would not have come this far if we hadn't made a series of smart decisions, my administration, a cooperative Congress—decisions we made together early on in my administration."
