Robert Phipps reported that the City of Fowler, Kingsburg, Orange Cove, Sanger, Selma and Fresno COG are missing. On behalf of the Fresno COG staff, the Local Budget Reports will be brought back in December.

Pursuant to the adopted Fresno County Transportation Authority procedures for administration of Measure C Extension Funds for Local Transportation Pass-Through Projects and Programs, and for Short Term Regional Transportation Program projects, local agencies are required to submit their Measure C Extension Expenditure Report(s) for the fiscal year no later than November 15th of each year. FCTA Flagged the ADA forms for the City of Clovis and Clovis Transit because it did not reflect any interest on that form. Ms. DiBenedetto had spoken to the City of Clovis and there was some discrepancy on that. Ms. DiBenedetto explained the Measure C Extension Expenditure Reports. Ms. DiBenedetto also explained that this year is a compliance audit that happens every five years. The FCTA is also evaluating that each agency has spent their mandate.

Ms. DiBenedetto also reported that any high reserves would be put out of compliance. All agencies that were being reviewed at the meeting are in compliance.

A motion was made by Kevin Hamilton and second by Bob Allen to accept the budget expenditure reports for 2016-17 with the exception noted for the City of Clovis for the interest and Fresno COG will be brought back in December. A vote was called for and the motion carried.

A motion was made by Kevin Hamilton and seconded by Bob Allen to amend the motion to also bring Kingsburg back in December. A vote was called for and the motion carried.
