WHEREAS, the Fresno Council of Governments has the authority to review claims and allocate such funds in accordance with the Transportation Development Act of 1971 and Chapter 3 of Title 21 of the California Administrative Code; and

WHEREAS, the County agrees to reserve the sum of \$2,139,704 and \$85,068 from its Local Transportation Fund and State Transit Assistance Fund allocations to be claimed by the City of Fresno and the City of Clovis, respectively, as payment for providing transit services to the unincorporated areas within the Fresno-Clovis Metropolitan Area; and

WHEREAS, the County agrees to reserve the sum of \$422,675 from its Local Transportation Fund allocation to be claimed by the Fresno County Rural Transit Agency to provide transit services to the rural areas within the County; and

WHEREAS, the County agrees to reserve the sum of \$303,291 from its Local Transportation Fund allocation to be claimed by the Clovis Consolidated Transportation Service Agency, the Fresno Urban Consolidated Transportation Services Agency, and the Fresno Rural Consolidated Transportation Services Agency to provide social services transit to the unincorporated areas within the Fresno-Clovis Metropolitan Area and to the rural areas within the County; and

WHEREAS, the Fresno Council of Governments encourages inter-jurisdictional coordination of transportation needs and increased coordination of transportation implementation plans; and

WHEREAS, the County has made a commitment to unmet transit needs through adoption of a Transportation Development Plan for the County and participation in a Joint Powers Agreement between

1 the County and the cities and communities in the rural portions of the County to provide transit services so  
2 that allocation of funds to finance the Joint Powers Agreement satisfies the requirement for establishing a  
3 schedule for transit implementation; and

4 WHEREAS, there are no additional unmet transit needs within the County.

5 NOW, THEREFORE, BE IT RESOLVED that the County of Fresno hereby requests the Council of  
6 Fresno County Governments direct \$2,139,704, \$85,068, \$422,675, and \$303,291 from the County's  
7 Local Transportation Fund and State Transit Assistance Fund allocations to the above named applicants  
8 for Fiscal Year 2016-17 for the purposes allowed under ARTICLE 4, ARTICLE 4.5, and ARTICLE 8  
9 respectively of the Transportation Development Act of 1971, as identified in the attached claim and which  
10 is in accordance with the adopted Regional Transportation Plan.

11 BE IT FURTHER RESOLVED that the named applicants further agree to provide the Fresno  
12 Council of Governments with such information as may be necessary to support their Annual Transportation  
13 Claims.


