**BE IT FURTHER RESOLVED,** that the City Council of the City of Firebaugh hereby requests that of the City's total Transportation Fund Apportionment for fiscal year 2018-2019; and thereafter, in the amount approved by resolution by the Fresno COG Policy Board, be allocated to the Fresno County Rural Transit Agency for the purpose of conducting a transportation program consistent with the adopted Regional Transportation Plan.

**BE IT FURTHER RESOLVED that** the named applicant further agrees to provide the Fresno COG with such information as may be necessary to support its annual transportation claim.
