# C. Development Types (Fregonese Associates)

Inputs on the development types have been incorporated. Fregonese Associates presented final draft development types. The presentation is available as an Exhibit to the agenda on the Fresno COG website. The prototype and development types were discussed and suggestions for additional information were also discussed.

A motion was made by John Wright (Regional Planner) and seconded by Elizabeth Jonasson (CCA) recommending that the development types be approved in order to pursue the next step in scenario development, with the understanding that development types could still be revised in the later stage should there be a need to. A vote was called for and the motion carried.

## D. Scenario Development (Kristine Cai and John Downs (FAX)

Mr. Downs made a brief presentation on the demographic market research and the 3 scenarios modeled in the Public Transportation Infrastructure Study (PTIS). A copy of this presentation is also available on the Fresno COG website. There was a lengthy discussion about the PTIS regarding changing demographics and land use patterns.

Following the discussion, Mr. Wright made a motion to consider three scenarios in the target setting process:

1. Baseline scenario, based on existing general plans

2. Proposed land use scenario, based on updated/proposed new land use from the cities/County
