## II. Action Summary of May 13, 2021 Meeting of the Measure C Citizen Oversight Committee

A motion was made by Bob Allen seconded by Ron Dressler to approve the May 13, 2021, Measure C Citizen Oversight Committee Action Summary with the removal of the RTP meeting update. A vote was called for and the motion carried.

## III. <u>Elect Chair and Vice Chair (Brenda Veenendaal)</u>

Brenda Veenendaal reported on this item. The Measure C Citizen Oversight Committee elected a chair and co-chair to serve the committee during the 2021-2022 fiscal year.

A motion was made by Bob Allen to seconded by Gail Miller to have Sal Petrucelli continue to serve as Chair on the COC. A vote was called for and the motion carried.

A motion was made by Sal Petrucelli and seconded by Bob Allen to have Jim Hunter serve as cochair on the committee for the next fiscal year. A vote was called for and the motion carried.

#### IV. Fresno COG RTP Roundtable Representative Nominations and Approval (Brenda Veenendaal)

Brenda Veenendaal reported on this item. The Oversight Committee currently holds a seat on the Fresno COG Regional Transportation Plan (RTP) Roundtable, a committee providing expertise and generating consensus on RTP development issues. The Roundtable meetings are held once a month on the fourth Wednesday at 1:00 pm via Zoom. COC's RTP Roundtable representative was Kevin Hamilton who termed out of the Oversight Committee on July 31, 2021. Kevin's alternate was Bill Jordan.

Staff requested that both positions be reappointed (or reaffirmed) by the Oversight Committee membership.

A motion was made by Bill Jordan and seconded by Bob Allen to approve Jim Hunter as representative for the Measure C Citizen Oversight Committee's RTP Roundtable and Bill Jordan as the alternate. A vote was called for and the motion carried.

## V. Measure C Renewal Update (Mike Leonardo)

The Fresno County Transportation Authority Executive Director, Mike Leonardo, gave an updated report on the Measure C Expenditure Plan renewal effort underway. Information regarding the renewal was located online.

## VI. FY21/22 Measure C Original Budget (Denise DiBenedetto)

Denise DiBenedetto reported on this item. This budget did not fall under the purview of the COC but is provided for reference to the project and administrative costs that are split between the Original Measure and the Extension Measure. This proposed 2021-22 Original Measure C budget had no estimated sales tax revenue during the fiscal year due to the expiration of the original

Measure C sales tax levy in 2007. However, it was estimated to gain \$600,000 in interest revenue which was to be used to fund the remaining urban and rural projects.

A narrative explaining the purpose of each expense was provided for each lined item within the budget.

Brenda Veenendaal introduced our newest member of COG Jake Martinez, to the Committee. Mr. Martinez gave a brief bio on himself.

#### VII. FY21/22 Measure C Extension Budget (Denise DiBenedetto)

Denise DiBenedetto reported on this item. The proposed 2021-22 Measure C Extension budget included an estimated sales tax revenue and interest earnings to be received during the 2021-22 fiscal year of \$90,752,699, a \$14.2 million increased over last year's approved budget. This revenue estimate reflects a moderately conservative 2% projected increase over 2020-21 actual revenues, which equates to a 18.6% increase over last year's approved budget. The 2020-21 budget reflected a cautious decline in revenues due to COVID, but actual revenues collected significantly exceeded those projections. Looking back to 2019-20, this proposed budget is an 8.9% increase, or 4.5% percent per year over 2019-20 which was the most recent year unaffected by COVID. The budget included approximately \$2.5 million in interest income.

Ron Dressler asked about the Twenty-Five million that was set aside. Ms. DiBenedetto said that the funds were withdrawn and put towards the Highway 41 project.

## VIII. FY21/22 Measure C RTMF Budget (Denise DiBenedetto)

Denise DiBenedetto reported on this item. The RTMF revenue projection was the result of a collaborative effort between the Fresno County Auditor-Controller/Treasurer-Tax Collector's office and RTMF Agency staff, which took into consideration projected development activity in Fresno County during the 2021-22 fiscal year. The fee income identified in this budget is the result of applying the RTMF fee schedule, as updated by the Board in January 2020, to the development activity estimated to take place during the upcoming fiscal year.

There were no proposed administrative salaries, benefits, or support costs proposed in this budget because the fee was calculated and collected by the RTMF Agency. Costs associated with RTMF Administration are also covered by a separate fee imposed and collected by the RTMF Agency.

As had been mentioned in previous budget presentations, Fresno County had been fortunate to receive previously unanticipated State and federal grants for local transportation projects. Although these grants allowed for early delivery of projects, they required local matching funds. Some of this local match was planned to be funded through the RTMF fee revenue. However, due to the 2008 recession, sufficient funds had not yet been collected. Rather than forgo the grant funding, COG and the Authority chose to deliver those projects early using money loaned to the RTMF fund from the original and extension Measure C funds. It remains the intent of both the Authority and COG that these loans will be repaid by the RTMF Fund to the Measure C funds.

The RTMF fund currently had an uncommitted fund balance of \$3,215,485 in cash and the budget under consideration today proposes to continue repaying the RTMF loans by transferring this current fiscal year's uncommitted fund balance to Measure C in 2021-22. Annual payback was included prior year uncommitted fund balance minus the anticipated Administrative

Expenditures. This payback process will continue annually to service the outstanding loan balance. The current outstanding loan balance as of March 31, 2021, is \$66,750,638 which reflects the total prior years payback of \$29,783,511 against the loan principal and accumulated interest. This budget is the continuation of that repayment effort.

The 2021-22 RTMF budget identifies an estimated \$4,800,000 million in fee collection revenue based on recent development activity in Fresno County and \$38,400 in interest earnings. The final category of resources available to deliver the RTMF construction program in 2021-22 is \$16,805,600 in Measure C Loans that was estimated to be needed to service ongoing construction contracts in the coming year. These funds are available, if needed, to pay costs as they come due for on-going contracts and will be added to the outstanding \$66,750,638 million Measure C loan identified above to be amortized over the remaining life of the fee program. Combining all the above listed resources, results in a total of \$24,859,485 available to deliver the 2021-22 RTMF Program.

The expenditure side of the proposed 2021-22 RTMF Budget identifies \$21,644,000 for construction projects, \$15,000 for Services and Supplies which is made up of an estimated \$5,000 for legal services and \$10,000 for Consultant Services to update the Strategic Implementation Plan as needed to reflect the changes resulting from the anticipated 2020 Measure C Expenditure Plan update and \$3,200,485 in Measure C RTMF Loan payback program.

The Measure C Citizen Oversight Committee was in charged with annually developing an annual report to the public. A subcommittee was formed to develop the report. The chair was accepting volunteers to sit on the subcommittee.

Sal Petrucelli, Jim Hunter, Ron Dressler and Bill Jordan volunteered to be on the subcommittee to develop the COC 2020-2021 Annual Report to the Public.
