II. Action Summary of August 12, 2021 Meeting of the Measure C Citizen Oversight Committee

IV. <u>Elect Citizen Oversight Committee Vice Chair</u>

The Measure C Citizen Oversight Committee elected a new co-chair to serve the committee during the 2021-2022 fiscal year.

Sal Petrucelli nominated Ron Dressler for Vice Chair of the COC.

A motion was made by Destiney Rodriguez and seconded by Bill Jordan to approve Ron Dressler as co-chair to serve on the Measure C Citizen Oversight committee for the next fiscal year. A vote was called for and the motion carried.

V. Fresno COG RTP Roundtable Representative Nominations and Approval

The Oversight Committee held a seat on the Fresno COG Regional Transportation Plan (RTP) Roundtable, the committee provided expertise and generating consensus on RTP development issues. The Roundtable was not currently meeting. Most of their work was completed. However, should they choose to meet again prior to the adoption of Fresno COG's 2022 Regional Transportation Plan/Sustainable Communities Strategy Update, meetings would be held once a month on the fourth Wednesday at 1:00 pm. COC's RTP Roundtable representative was Jim Hunter. The alternate was Bill Jordan.

Staff requested that both positions be reappointed (or reaffirmed) by the Oversight Committee membership.

A motion was made by Carla Stanly and seconded by Destiney Rodriguez to approve Bill Jordan as representative of the Measure C Citizen Oversight Committee's RTP Roundtable and Sal Petrucelli as the alternate appointments. A vote was called for and the motion carried.

VI. Measure C Renewal Update (Staff)

The Fresno COG and Fresno County Transportation Authority staff gave a report on the Measure C Expenditure Plan renewal effort underway. Information regarding the renewal was located online at this link.

Price Paige & Company Accountancy Corporation was retained by the Authority to perform the audit of finances on all local agencies receiving Measure C Extension revenue as required in the 2006 Measure C Extension Expenditure Plan. The firm completed their analysis and submitted the final report for fiscal year ending June 30, 2019 audit of finances, which had been provided in your board packet. In summary the firm stated that overall, local agencies continue to adhere to the record keeping and reporting requirements, as well as expending Measure C funds in accordance with provisions of the Measure C Transportation Sales Tax Extension.
