#### B. <u>Temporary Maintenance Facility Lease Agreement Extension [APPROVE]</u>

**Summary:** The Board approved in January 2024, the lease agreement extension (12/31/2023-12/31/2024) for a temporary maintenance facility while the permanent maintenance facility is being built. The temporary site in Selma is located at 1870 Dockery Ave in the City of Selma across from the City yard and around the corner from the new maintenance facility site. FCRTA maintenance services will remain at this location and renew the lease up to an additional six months while the new maintenance facility is being constructed. The monthly rent will be \$6,200 per month. The agreement extension is available on the website <u>www.ruraltransit.org</u>.

<u>Action:</u> Staff recommends Board approval of the agreement extension for the maintenance facility lease not to exceed six months (12/31/2024-6/30/2025).

#### C. Amendment I New Technology Grant Program Kingsburg Resiliency Hub Project [APPROVE]

Summary: FCRTA was awarded a project through the Fresno Council of Governments (FCOG) Measure C New Technology Reserve Grant Program. FCRTA was also previously awarded \$538,200 for Phase 1 partial funding of this project which included the solar and level 2 plug-in charging units. FCRTA's project includes funding for Phase 2 to complete this project which consists of construction of the resiliency hub including inductive chargers, battery storage, energy management system, and concrete in a public parking lot in downtown Kingsburg. The resiliency hub will include electric vehicle charging infrastructure that will enable FCRTA to transition to a fully electric vehicle fleet. The hub will also allow FCRTA to expand its innovative on-demand EV Micro Transit service to bring more riders to the system and better connect rural communities to jobs, healthcare, social services, and other qualityof-life locations. The solar chargers would also further reduce reliance on the electrical grid, bringing FCRTA's fleet closer to zero emissions. For increased resiliency, FCRTA plans to install a battery energy storage system (powered-microgrid) to store energy generated by the solar infrastructure. This energy will provide critical backup power when solar generation rates are low. FCRTA was awarded \$986.936 in funding for this project. FCRTA will enter into an amendment with FCTA as the administrator of the grant funding. The Amendment I includes Phase 1 and Phase 2 of the project. The Amendment I is available on the website at www.ruraltransit.org

<u>Action:</u> Staff recommends Board authorize the General Manager to enter into an agreement with FCTA for the New Technology Reserve Grant Program in the amount of \$1,525,136.

#### D. Fiscal Year 2023-2024 Audit [ACCEPT]

**Summary:** The CPA firm Price Paige and Co. have completed the 2023-24 Financial and Compliance audit for FCRTA. The report details that FCRTA managed its operations according to funding covenants, within budget and has no findings of non-compliance. This report satisfies requirements of local, federal, and state funding agencies.

FCRTA's operating revenues were \$171,226 and operating expenses were \$10,666,858, which includes \$2,507,707 for depreciation. Non-operating revenues were \$7,987,925; however, when depreciation is netted out, revenues and expenses are in balance. Capital contributions net of depreciation were \$8,265,141, resulting in an ending net position of \$19,782,001. Copies of the audit will be available at the meeting to interested parties and available on FCRTA's website www.ruraltransit.org.

Action: Staff recommends Board acceptance of the 2023-24 FCRTA Financial and Compliance Audit.

#### E. Biola Microtransit Program [ACTION]

**Summary:** FCRTA deployed a rural microtransit program in the community of Biola. This service is operated by FCRTA's subcontractor MV transportation with an electric chevy bolt vehicle. The driver is a local resident of biola and an employee of MV transportation, FCRTA also installed a charging unit to charge the vehicle at the Biola Community Services District (BCSD) to eliminate the deadhead time. The League of Women Voters have donated \$12,000 that are being used as a 50% subsidy for fares for passengers.

This microtransit program has been on a demonstration basis and staff has been monitoring ridership and costs. The ridership for this program continues to be low and costs are high, for the period of 7/1/23 to 6/30/24 the cost per passenger is \$72.00 and cost per hour is \$52.00. The MOU with the BCSD will be ending in February 2025 and FCRTA will not be renewing this MOU. FCRTA will be terminating the service in February 2025 due to the high costs. FCRTA has met with the League of Women Voters and they support ending the service. Staff will continue to explore other transportation options for Biola.

<u>Action:</u> Staff recommends Board approval of terminating the Biola Microtransit Program in February 2025.

## F. Current FCRTA/FCOG Office Conditions [INFORMATION]

**Summary:** Last month, the Board was informed of the current conditions of the FCRTA/COG office and that the space has been infested with pests. FCRTA General Manager has met with the FCOG Executive Director on this subject and will continue to discuss options or alternatives. FCRTA will return to the Board with possible options. At this time, staff recommends assembling a Committee to discuss options that are presented by staff. Between now and when the lease is up for renewal in 2025, FCRTA will continue to confer with FCOG about possible relocation options for both offices with emphasis to stay in the downtown area depending on availability.
