## **Results to date**

There were 619 views of the Unmet Transit Needs Survey, leading to 63 participants, and 47 commenters, providing 253 responses, and 110 comments. Several commenters left more than one comment. Last week, transit agencies were provided with an initial list of 34 legitimate comments to review. They were provided with additional relevant comments to review as they became available.
