The Renewal Committee is tasked with developing a draft expenditure plan for the renewal effort, as well as recommend a final expenditure plan for consideration of the county's jurisdictions, Fresno COG Policy Board, Fresno County Transportation Authority, and the Fresno County Board of Supervisors. The Measure C 2026 Technical Advisory Committee (TAC) will convene its first meeting on Wednesday, May 14th from 2pm to 4pm. The TAC is made up of jurisdictional, transit agency, and Caltrans staff to advise the Renewal Committee on jurisdictional and agency priorities as well as structures of existing programs that utilize local, state, or federal funds.
