**1. Call Meeting to Order and Roll Call**

THE MEETING WAS CALLED TO ORDER AT 5:45 P.M. BY MAYOR MARTINEZ (CHAIR). ROLL CALL WAS TAKEN 12 MEMBERS PRESENT. MEMBERS HURON, SANGER AND SAN JOAQUIN ABSENT. THERE WAS A QUORUM TO CONDUCT BUSINESS.

**2. Approval of February 27, 2025, Minutes**

A MOTION WAS MADE BY MAYOR BELTRAN (PARLIER), SECONDED BY MAYOR VALDEZ (FIREBAUGH) TO APPROVE THE ACTION SUMMARY MINUTES AS PRESENTED. A ROLL CALL VOTE WAS CALLED AND THE MOTION PASSED, 12 YES, MEMBERS HURON, SANGER AND SAN JOAQUIN ABSENT.

**3. CAL-ID RAN BOARD [APPOINT]**

Appoint one (1) Member to the Cal-ID RAN Board, to the seat previously held by Lynn Ashbeck, for an indefinite term.

Note: The City Selection Committee shall appoint one mayor (Penal Code § 11112. 4).  
This item returns to the committee after being tabled at the February 27, 2025, meeting.

MAYOR PURSELL (KINGSBURG) RECUSE HIMSELF FROM DISCUSSION AND VOTE.  
CHAIR MAYOR MARTINEZ OPENED FOR NOMINATIONS.

MAYOR MARTINEZ (MENDOTA) MOTIONED TO APPROVE FREDDY VALDEZ (FIREBAUGH), SECONDED BY MAYOR MOUANOUTOUA (CLOVIS). A ROLL CALL VOTE WAS CALLED. THE MOTION PASSED, 11 YES, MEMBERS HURON, SANGER AND SAN JOAQUIN ABSENT.

**4. LOCAL AGENCY FORMATION COMMISSON (LAFCo) [APOINT]**

Appoint one (1) Member to the Local Agency Formation Commission (LAFCo), to the seat currently held by Gary Yep, whose current term will expire May 5, 2025. The new term will be effective May 5, 2025, and will expire May 7, 2029.

Note: The City Selection Committee appoints two (2) mayors/council members to serve as Members and one (1) mayor/council member to serve as an Alternate Member (Government Code§ 56325(b)).

MAYOR PRO TEM YEP – 1 VOTE (KERMAN)

MAYOR MARTINEZ – 9 VOTES (CLOVIS, COALINGA, FIREBAUGH, FOWLER, KINGSBURG, MENDOTA, ORANGE COVE, PARLIER, REEDLEY)

MEMBERS HURON, SANGER AND SAN JOAQUIN ABSENT.

MAYOR VICTOR MARTINEZ WAS APPOINTED.
