FCOG shall compensate Law Firm as follows:

We understand that other attorneys need to be approved by FCOG's general legal counsel, Executive Director, or designee prior to provision of services. In the case that other attorneys are approved upon to work on this or other matters that might arise with FCOG, those attorneys will bill at then-current individual public rates which are based on experience and areas of expertise.

Hourly rates for those attorneys fall within the following ranges: Partners and Of Counsel range from \$305 - \$670 per hour; Associates range from \$260 - \$330 per hour, Paralegals, Law Clerks and Analysts from \$145 - \$270 per hour, and Consultants and Government Affairs from \$260 - \$470 per hour. Beginning July 1, 2026, our rates will be adjusted annually with advanced written notice. Rate adjustments usually follow market trends as well as the Consumer Price Index (CPI) as is appropriate for each of our areas of specialization.
