The RTP and Measure C

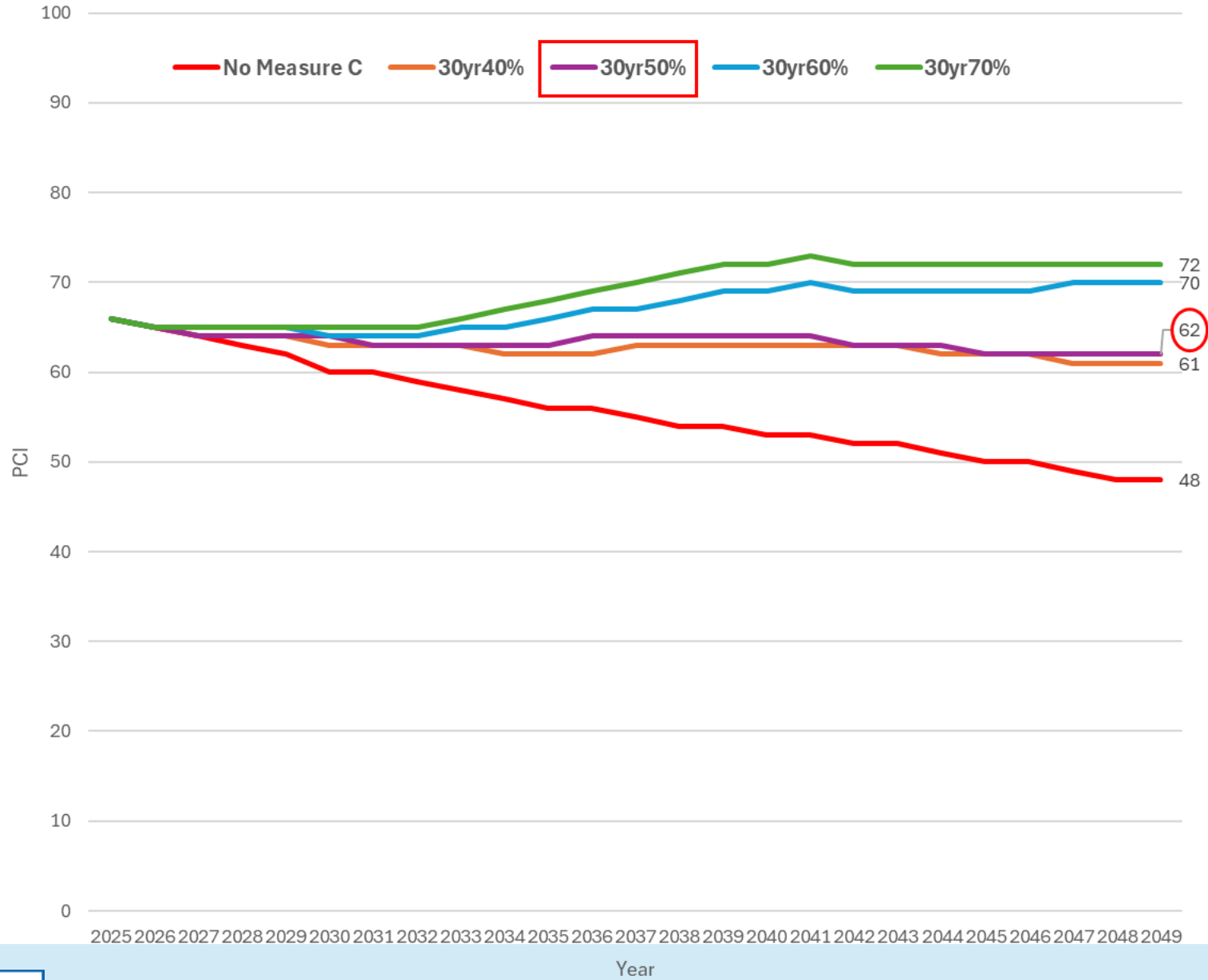
- Fresno COG's 2026 Regional Transportation Plan runs from 2026 to 2050. The Steering Committee has approved a recommendation of Measure C as a 30-year measure from 2027 to 2057.
- Due to the time gap of 7 years between the RTP's horizon year and the Measure C 2026 horizon year, this analysis is a bit of an apples-to-oranges comparison. Staff will show Measure C revenue running till 2050, to try to account for this discrepancy between the two horizon years.
- Staff is also aware that the later into the RTP period this analysis goes, there is less certainty around if enough projects have been identified by the cities and agencies. This is an issue that comes up on RTPs because long-term needs are harder to identify compared to short-term and medium-term needs. As such, staff believes there will be more projects and funding need than what we are presenting to you today. This is our best approximation with the information available to Fresno COG today.

Existing Neighborhood Roads

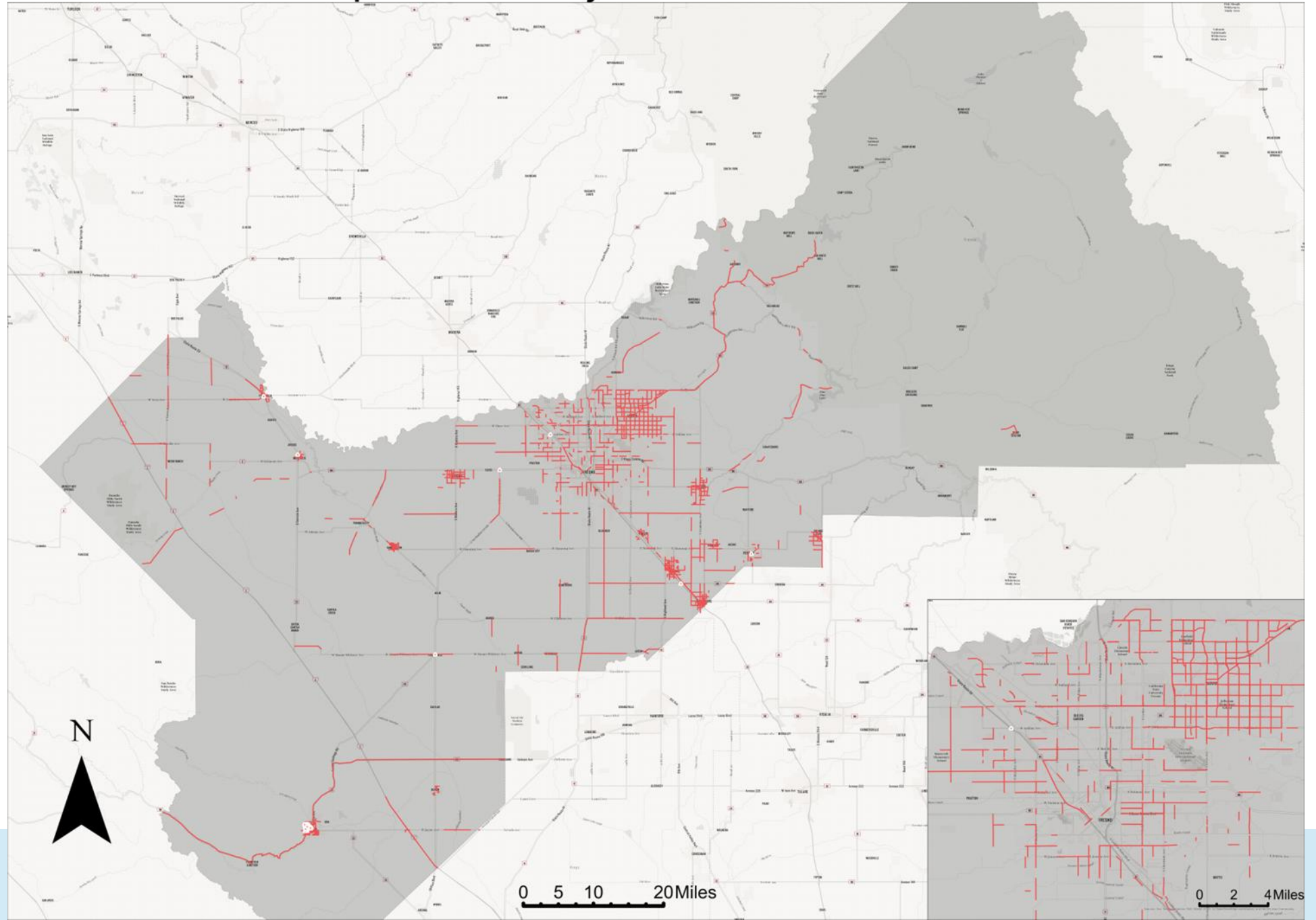
- Based on formulas used in distributing funding for the state's gas tax, Measure C has historically used a 75% population & 25% road miles formula for the local road maintenance programs.
- The 2006 Measure established a \$100,000 annual distribution to every jurisdiction before the formula kicks in. For this measure, we're showing that annual distribution increased to \$200,000 which was proposed in the 2022 Measure.

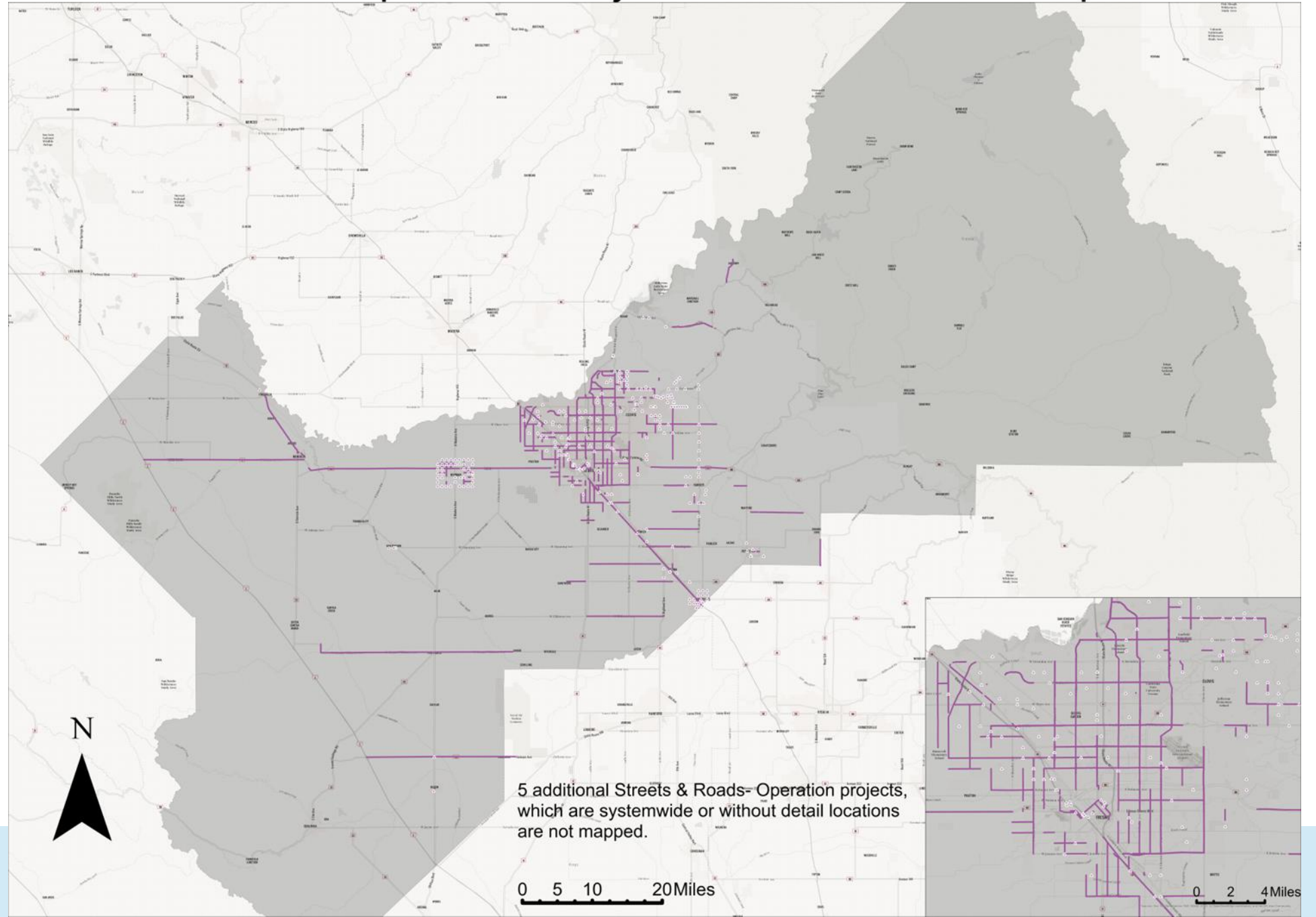
Pavement Condition Index Analysis

Public Transportation

Based on formulas used in distributing funding for the State's Transit Assistance (STA) Program and the federal Transportation Development Act (TDA) Program, Measure C has historically used a 70% (FAX), 20% (FCRTA), 10% (Clovis Transit) formula for the three transit agencies.

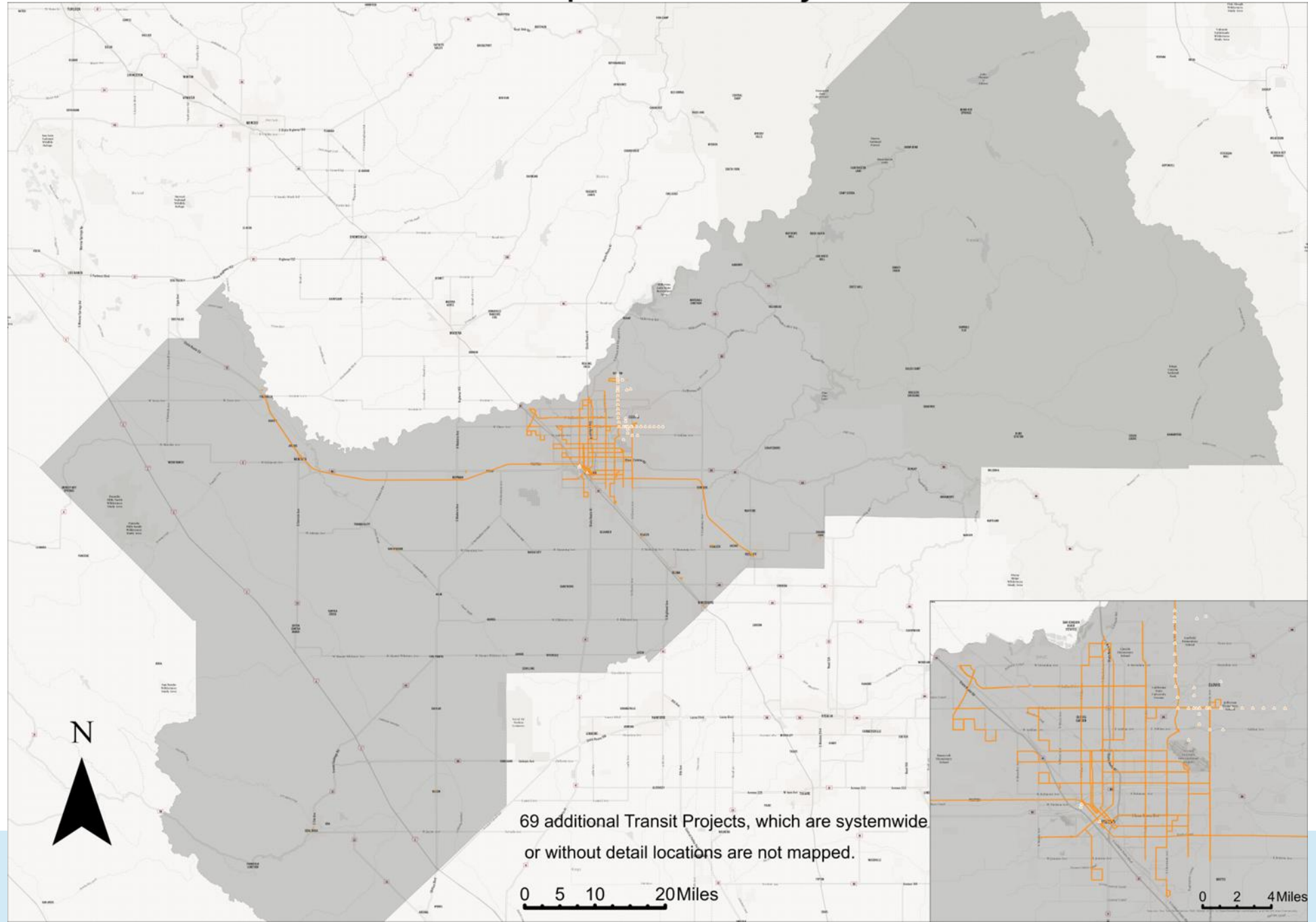

Public Transportation

- Projects the transit agencies have planned for over the next 30 years include:

 - Increased Service Frequencies (\$100M)
 - West Area Service Expansion (\$20M)
 - Southwest Service Expansion (\$25M)
 - Peach Avenue Service Expansion (\$1.5M)
 - Bullard Avenue Service Expansion (\$7.3M)
 - Roeding Park Service Expansion (\$2.8M)
 - Veterans Boulevard Service Expansion (\$2.5M)
 - Mobility Hubs (\$6M)
 - Extended Weekend Service Hours (\$2.5M)
 - Expanded Night Service (\$3M)
 - Microtransit Service (\$9M)
 - FAX Peak Time 15 min Frequency System-Wide (\$80M)

Active Transportation

- Based on formulas used in distributing funding for the state's gas tax, Measure C has historically used a 75% population & 25% road miles formula for the active transportation program.
- The current Measure C allowed for cities under 25,000 population* to make their Active Transportation funds flexible and eligible for other transportation projects due to their small annual apportionments not being sufficient to fund a single project each year.

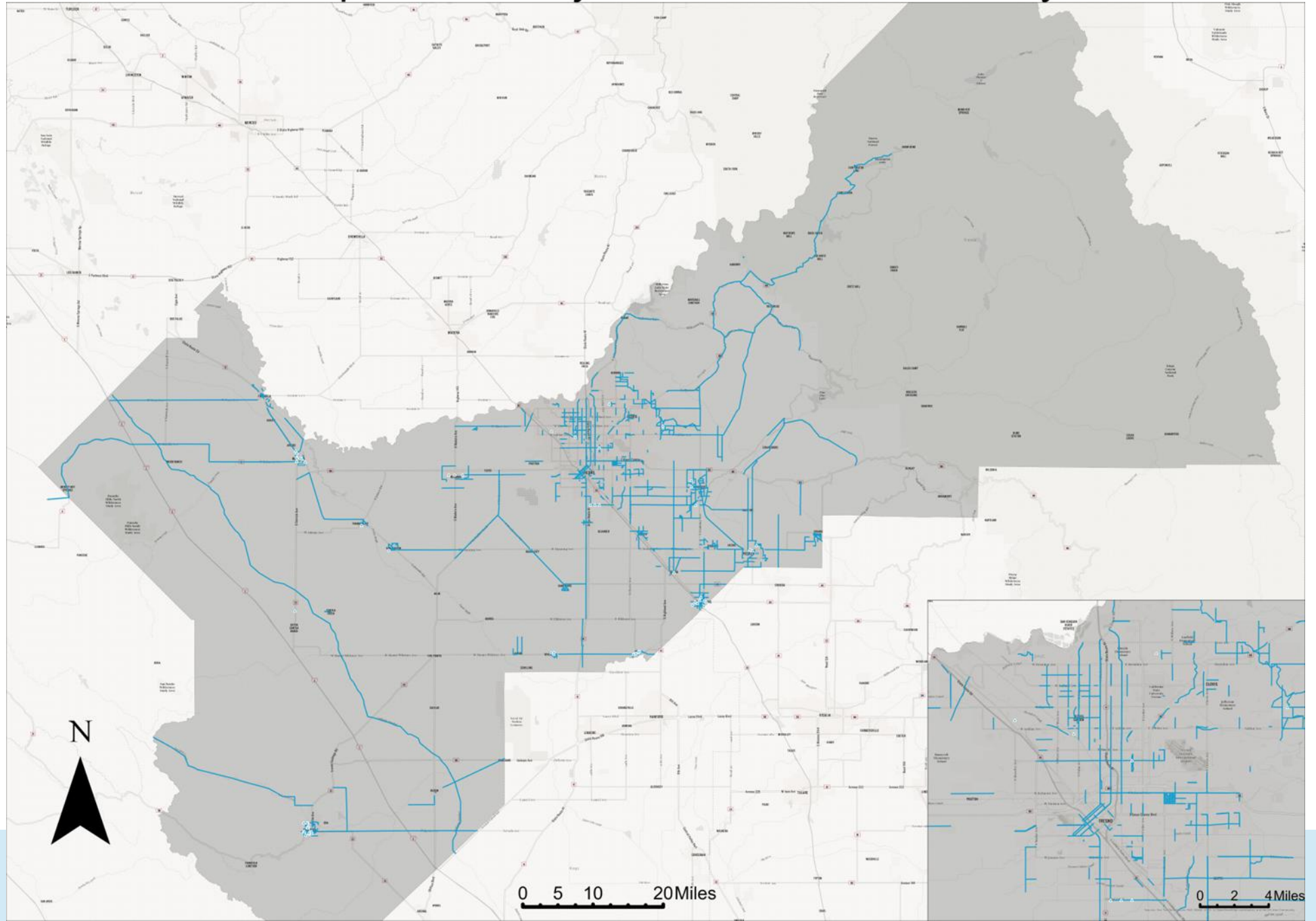

2026 RTP Transportation Projects - Pedestrian and bicycle facilities

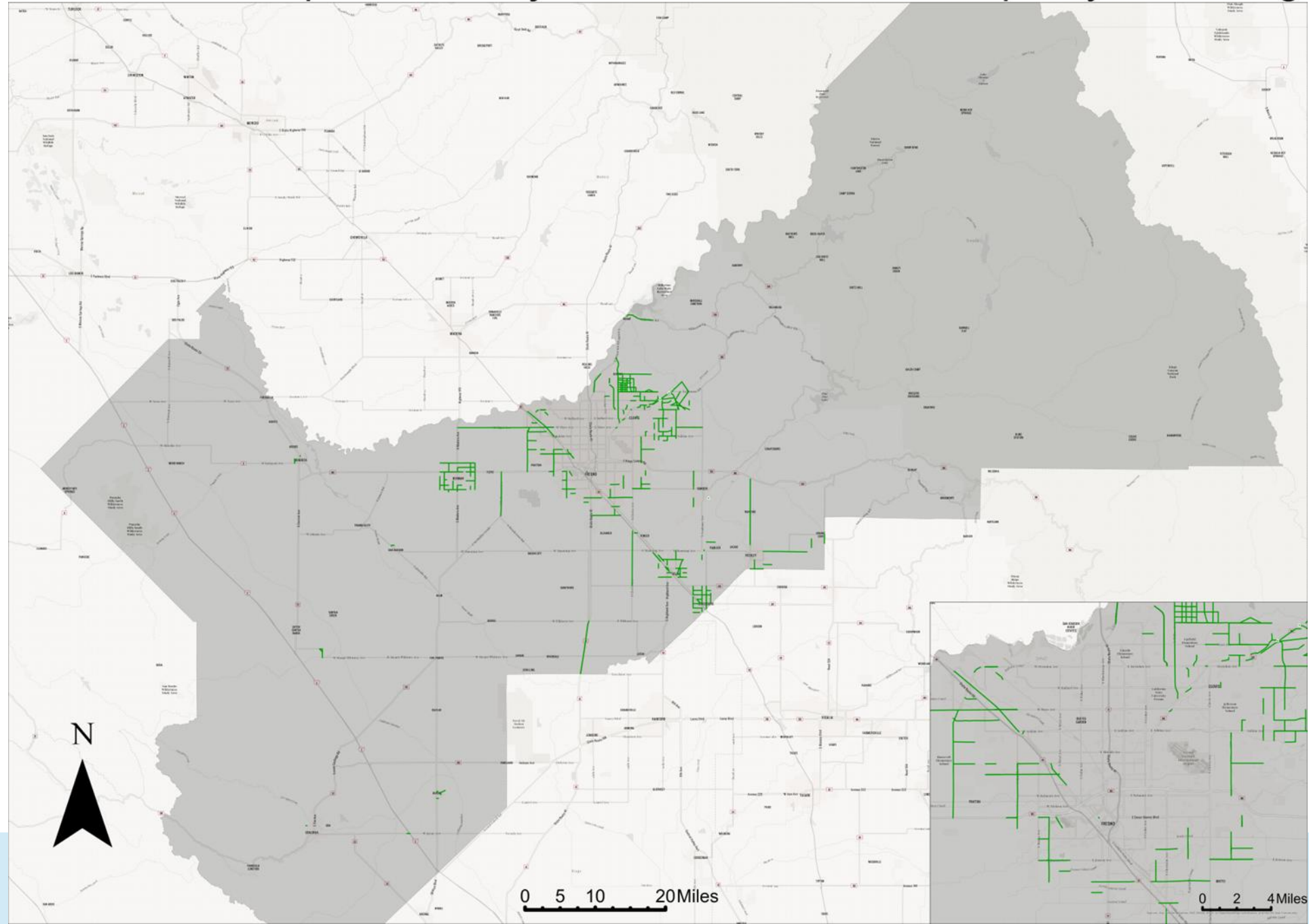


Regional Connectivity
