### Fresno "One Voice" Trip – March 22 – 26, 2026

Fresno COG is planning its annual One Voice Trip to Washington, D.C. and is holding 20 hotel rooms with three spots committed to COG staff and the Fresno COG Policy Board Chair, at \$409 per night + 15.95% room tax.

**Registration Fees:** A non-refundable \$300 registration fee is required for each participant attending the 2026 One Voice trip. The fee and delegate form are due no later than February 27, 2026. This fee covers all materials, meeting refreshments and ridesharing services. You will be billed for any remaining charges over \$300 that Fresno COG may incur on your behalf. Fresno COG is not responsible for hotel charges, room incidentals, shuttle service to and from the airport, alcohol or meal purchases other than what is indicated. Any additional reimbursements owed to Fresno COG must be remitted no later than April 30, 2026. Registration fees apply to One Voice participants only.

**Delegates' guest(s):** One Voice participants bringing spouses or guests to group tours, dinners or meetings should complete and submit the guest participation form and a trip deposit fee of \$200. The fee covers mid-week transportation, refreshment costs, meeting materials and other essentials.

**Metro Passes:** Metro transit passes may be included with registration if it is deemed necessary and are good for seven days with unlimited trips.

**Planned dinners requiring prior reservations:** Delegates registering for a group dinner where prior reservations are required will be charged if they cancel after the announced deadline or if they fail to attend. Guests attending group dinners will also be charged unless otherwise specified.

**Morning Meals and Meeting times:** Participants will be responsible for their own breakfast each morning unless otherwise announced. Morning briefings may be held at set meeting locations. All participants must be ready to leave the hotel at designated times, allowing adequate time to travel to meeting locations, go through security checkpoints and be escorted to meeting rooms. Attending the Monday evening delegation dinner and morning briefings is required to properly prepare for delegate meetings.

**Hotel Accommodations:** All participants will be responsible for making, modifying, or canceling their own hotel reservations. Guests must make their own reservations online at <https://book.passkey.com/e/51179838>.

**All reservations must be made on or before Sunday, March 1, 2026.** Twenty rooms are available for One Voice delegates, but we can expand that room block if we are sure delegates will need them. All reservations must be guaranteed with a major credit card.

**PLEASE NOTE:** Charges for room cancellations **after March 1, 2026, become the delegate's responsibility** if the room nights are not rebooked by another Fresno COG delegate.

**Transportation:** Participants are responsible for booking their own transportation to and from Washington, D.C. Delegates arriving on the same flight with Fresno COG staff may opt to join Fresno COG's travel reservations from the airport to the hotel.

For legislative advocacy purposes, Fresno COG exclusively reserves the right to use the One Voice moniker. No delegate or agency will advocate separately on any issue other than those agreed upon by the Fresno Council Policy Board at any time while using the One Voice name.

While this admonition does not preclude delegates from extending their stay in Washington D.C. or from bringing additional staff or representatives during the One Voice trip timeframe, additional staff members or representatives may not use the One Voice name to advocate during non-sanctioned activities.

In addition, any person committed to attending the One Voice trip must participate in all scheduled appointments assigned and not hold separate meetings during One Voice DC meeting hours unless previously discussed and agreed upon by the One Voice delegates.

### **Expenses**
