The meeting was called to order at 10:03 a.m. by Mr. Jansons (Kerman), Chair. With 10 members present, there was a quorum to conduct business.

**JOINT Transportation Technical/Policy Advisory Committee**

**A. Caltrans Report (Caltrans) [INFORMATION]**

Braden Duran reported on the latest Caltrans projects within Fresno County.

**I. TRANSPORTATION CONSENT ITEMS**

**A. Executive Minutes of November 14, 2025 [APPROVE]**

All items on the consent agenda are considered to be routine and non-controversial by COG staff and will be approved by one motion if no member of the Committee or public wishes to comment or ask questions. If comment or discussion is desired by anyone, the item will be removed from the consent agenda and will be considered in the listed sequence with an opportunity for any member of the public to address the Committee concerning the item before action is taken.

After an opportunity for public comment, Ms. Cabrera (San Joaquin) motioned, and Ms. Zieba (Reedley) seconded to approve the consent agenda.

**All in Favor, no opposed.  
Motion passed.**

**II. TRANSPORTATION ACTION/DISCUSSION ITEMS**

**A. Final Measure C Renewal Implementation Guidelines (Robert Phipps) [ACTION]**

Summary Executive Director Robert Phipps outlined the 2026 Measure C Implementation Guidelines as approved by the Measure C Steering Committee, calling out several points understood to be controversial. Together, the

Implementing Guidelines and the Category Allocations comprise the 2026 Measure C Expenditure Plan. The marked-up version of the Implementing Guidelines attached to the report presented also includes minor, clarifying revisions, such as the requirement to reach a minimum 65 pavement condition index (PCI) for every road in a jurisdiction prior to access funding for any widening project (with specified exemptions), or adding restriping bicycle lanes as an eligible maintenance expense. Phipps presented a PowerPoint presentation that summarizes the comments received on the most controversial issues, by category, and how those issues have ultimately been addressed.

- Objection from the County regarding the requirement for a minimum 65 pavement condition index (PCI) score (average 70) before any funds for widening may be accessed.
- Objection from County over recreational trails being ineligible
- Objections from the County to the 12-15 percent set-aside for disadvantaged, unincorporated communities, as well as the annual requirement for spending.
- A question on program requirements no. 5, (construction or maintenance)
- A City of Fresno request to maintain equipment costs as used in the current measure
- Objections from the County to the requirement (p. 19) No. 6 that every expressway, super-arterial, etc. shall include minimum bicycle travel accommodations.
- Comments that the document generally lacks accuracy and consistency.
- General call for more time for transportation technical staff to vet the guidelines.

After considerable discussion, the City of Fresno moved to approve the Implementing Guidelines and Expenditure Plan as recommended by staff. The City of Clovis provided the second motion. The vote was 4-5 against. The cities of Firebaugh, Kerman, Kingsburg, Reedley and County of Fresno opposed. The cities of Clovis, Fresno, Mendota and San Joaquin supported. The motion failed.

**Vote: 4 Yes, 5 No.**

**Motion failed.**

Fresno COG's One Voice delegation seeks funding sources for projects that appeal to federal decision makers and advocates for congressional and federal agency support during the competitive grant processes. By advocating for policy and regulatory reform, Fresno COG's One Voice effort is responsible for legislation that today streamlines the way federal and state agencies work together while eliminating unnecessary procedures so government agencies and the business community can work together seamlessly toward job creation for our communities.


