The meeting was called to order at 8:35 a.m. by Mr. Stites (FCRTA), Chair.

I. TRANSPORTATION CONSENT ITEMS

A. Executive Minutes of November 14, 2025 [APPROVE]

- Mr. Khorsand (County of Fresno) motioned, and Mr. Burnett seconded to approve the consent agenda.

All in Favor, no opposed.

Motion passed.

II. TRANSPORTATION ACTION/DISCUSSION ITEMS

A. Final Measure C Renewal Implementation Guidelines (Robert Phipps) [ACTION]

Summary: Executive Director Robert Phipps outlined the 2026 Measure C Implementation Guidelines as approved by the Measure C Steering Committee, calling out several points understood to be controversial. Together, the Implementing Guidelines and the Category Allocations comprise the 2026 Measure C Expenditure Plan. The marked-up version of the Implementing Guidelines attached to the report presented also includes minor, clarifying revisions, such as the requirement to reach a minimum 65 pavement condition index (PCI) for every road in a jurisdiction prior to access funding for any widening project (with specified exemptions), or adding restriping bicycle lanes as an eligible maintenance expense. Phipps presented a PowerPoint presentation that summarizes the comments received on the most controversial issues, by category, and how those issues have ultimately been addressed.

TTC comments included:

- Objections from County over recreational trails being ineligible
- A suggestion from City of Reedley to make 5% construction requirement (p. 16) item 2a instead of item 3a.
- Objections from the County to the 12-15 percent set-aside for disadvantaged, unincorporated communities, as well as the annual requirement for spending.
- A question on program requirements no. 5, (construction or maintenance)

- A City of Fresno request to maintain equipment costs as used in the current measure
- A Fresno County Rural Transit Agency (FCRTA) request that cost-efficacy be a factor in microtransit programs personal vehicle use.”
- A request to add restriping bicycle lanes as an eligible expense (p. 21)
- Objections from the County to the requirement (p. 19) No. 6 that every expressway, super-arterial, etc. shall include minimum bicycle travel accommodations.
- After considerable discussion, Jennifer Clark moved to approve the Implementing Guidelines and Expenditure Plan as recommended by staff. Ryan Burnett, City of Clovis, provided the second motion. The vote was 5-5 . The motion failed. Supporting the motion were: the cities of Clovis, Fresno, Mendota, San Joaquin and the Fresno Cycling Club. Opposing the motion were the County of Fresno (2 votes), cities of Fowler and Reedley and the Fresno County Rural Transit Agency.

Vote: 4 Yes, 5 No.

Motion failed.
