Develop a standardized waiver template and expedited review process to allow states to submit streamlined requests on behalf of participating local areas. 3. Provide technical assistance and model One-Stop certification criteria integrating virtual service delivery, customer satisfaction, programmatic access, and physical accessibility. 4.
