Note: The City Selection Committee appoints two (2) members representing cities within the county (other than the cities of Fresno and Clovis) – one (1) westside member appointed by a committee comprised of the mayors of each of those cities west of State Highway Route 99 and one (1) eastside member appointed by a committee comprised of the mayors of each of those cities east of State Highway Route 99 (California Public Utilities Code § 142051(d))
